 $3M^{\text{TM}}$ Venture Tape $^{\text{TM}}$ 3686FLE is a double coated tissue tape coated on both sides with a versatile cold weather acrylic pressure sensitive adhesive (PSA). This thin, strong, conformable tissue features high tack, high adhesion, high shear strength and excellent low and elevated temperature performance. A finger lift edge (FLE) is supplied for easy release liner removal. This construction is specifically designed as a self adhesive closure system on the longitudinal lap of jacketed pipe insulation (SSL - self seal lap) using ASJ facing.

Special Considerations

The extended liner provides a dry edge on both edges of the tape for easy liner removal. Stated product widths include the dry edge of the liner.

- Liner side adhesive: The width of the adhesive on the liner side is narrower than the liner by the amount of the dry edge/s.
- Exposed side adhesive: The adhesive on the exposed side is the full width of the product and liner. This helps to establish increased differential in adhesion of the exposed side vs the liner side to further aid in easy removal of the liner.

Storage and Shelf Life

It is suggested that products are stored at room temperature conditions of 70°F (21°C) and 50% relative humidity. If stored properly, product retains its performance and properties for 18 months from date of manufacture. Note: The shelf life may be shortened if the original packaging is not properly sealed or stored in an environment with high temperatures or humidity
