

Pipe Support Bracket and Zip Hanger Limited Warranty

Subject to the terms and conditions of this Limited Warranty ("Warranty"), Jones Stephens warrants that its products shall be free from defects in material and workmanship, under normal conditions of use when installed by a professional in proper applications for a period of TWENTY FIVE YEARS.

Scope

The scope of this Warranty includes Jones Stephens Quick Zip Pipe Hanger and Adjustable Pipe Support Bracket with Glide clamp for a period of TWENTY FIVE (25) YEARS from the date of installation in its original location.

How to Obtain Warranty Service

In order to file a claim under the terms of this Warranty, claimant must send written notification to Jones Stephens that a product may be defective along with proof of purchase within 30 days of the suspected failure or defect and within the applicable warranty period via mail or as outlined at the link shown below:

If Jones Stephens determines that a product identified above has failed or is defective within the scope of this Warranty, Jones Stephens's liability hereunder is limited, at the option of Jones Stephens, to issue a refund of the purchase price or to replace the defective product or component or part thereof which is proved to be other than as warranted.

Conditions & Exclusions

In order for the Warranty to be in effect, the applicable Jones Stephens products must be:

- Installed in accordance with the installation instructions provided by Jones Stephens;
- Installed by a professional in accordance with applicable building, mechanical, plumbing or other appliable code requirements and standard industry practice; and
- Installed in an end-use environment intended for the Product;
- In its originally installed location; and

In addition to the conditions above, this Warranty does not apply when product failure or resulting damages are caused by:

- Faulty installation;
- Misuse, tampering, mishandling, neglect, or accidental damage;
- · Components not manufactured or sold by Jones Stephens;
- · Abnormal operating conditions; or
- Any other cause beyond the control of Jones Stephens.
- Exposure to chemicals
- Exposure to excessive UV
- Exposure to acidic water pH < 6.5 or Alkaline water pH >8
- Water pressures and flow conditions outside the working conditions of this product
