Scotch® Filament Tape 893 is a general-purpose packaging tape reinforced along its length with continuous glass-yarn filaments, which give the tape high tensile strength. The transparent polypropylene backing provides excellent abrasion, moisture and scuff resistance. The adhesive is an aggressive rubber adhesive specifically formulated to provide balanced performance having both high adhesion and long term holding power.

Application of Scotch® Filament Tape 893 is most easily accomplished at room temperature. At colder temperatures, approaching 32°F (0°C), the adhesive becomes firmer. Once applied, Scotch® Tape 893 performs well throughout the normal temperature ranges typically encountered by packaged products in shipping and storage environments.
