# **D10-PFP INSTRUCTIONS**

The D10-PFP is a sturdy, rack-mountable power distributor featuring ten circuit breaker protected rear panel outlets. Install a D10-PFP in your rig or component rack to safely power all of your equipment.

Note that the D10-PFP is a power distributor only, and offers no conditioning or surge protection functions, making it an ideal extension to an existing branch circuit.

### **MAXIMUM LOAD:**

The ten circuit breaker protected outlets are rated at 15 Amps, which is equivalent to 1800 Watts at 120 Volts. If the total load on the D10-PFP (combining all outlets) exceeds 15 Amps, the circuit breaker (located on the front panel) will trip, cutting off power to all connected equipment. Should this happen, reduce the load by unplugging one or more units from the D10-PFP, then push the circuit breaker button in to reset it.

## **CAUTION:**

Only for use with 15 Amp circuits utilizing a minimum of 14 AWG.

### **LIMITED ONE YEAR WARRANTY**

All PF Power/Panamax Warranties and Product Policies are valid only in the United States and Canada.

**SAVE YOUR SALES RECEIPT!** Your receipt is your proof of purchase and confirms the product was purchased at an authorized PF Power dealer. It will need to be submitted to PF Power in order to process any warranty claims.

PF Power, a brand of Panamax Inc., warrants its D10-PFP (the "Product") as follows:

PF Power warrants to the original Purchaser of the Product that the Product sold hereunder will be free from defects in material and workmanship for a period of one year from the date of purchase. If the Product does not conform to this Limited Warranty during the warranty period (as herein above specified), Purchaser shall notify PF Power of the claimed defects by calling Panamax Inc. at 1-800-472-5555. If the defects are of such type and nature as to be covered by this warranty, PF Power shall authorize Purchaser to return the Product to Panamax headquarters. Warranty claims **MUST** be accompanied by a copy of the original purchase invoice showing the purchase date. Shipping charges to Panamax headquarters must be prepaid by the Purchaser of the Product. PF Power shall, at its own expense, furnish a replacement Product or, at PF Power's option, repair the defective Product. Return shipping charges back to Purchaser will be paid by PF Power.

THE FOREGOING IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
