

LED HIGH BAY INSTALLATION INSTRUCTIONS

Models: HBL4105UV#, HBL4155UV#, HBL4210UV#, HBL4300UV#

To reduce the risk of death, personal injury or property damage from fire, electric shock, falling parts, cuts/abrasions, and other hazards read all warnings and instructions included with and on the fixture box and all fixture labels.

- Before installing, servicing, or performing routine maintenance upon this equipment, follow these general precautions.

 Commercial installation, service and maintenance of luminaires should be performed by a qualified licensed electrician.

 For the installation: If you are unsure about the installation or maintenance of the luminaires, consult a qualified licensed electrician and check your local electrical code.
- To prevent wiring damage or abrasion, do not expose wiring to edges of sheet metal or other sharp objects.
 Do not make or alter any open holes in an enclosure of wiring or electrical components during kit installation.



- Turn off electrical power at fuse or circuit breaker box before wiring fixture to the power supply.
 Turn off the power when you perform any maintenance.
- •Verify that supply voltage is correct by comparing it with the luminaire label information.
 All wiring connections should be capped with UL approved wire connectors.

- Avoid direct eye exposure to the light source while it is on.
- •Account for small parts and destroy packing material, as these may be hazardous to children.
- •Risk of burn. Disconnect power and allow fixture to cool before handling fixture.

NOTICE: Green ground screw provided in proper location. Do not relocate.

NOTICE: Minimum 90° supply conductors. NOTICE: Specifications and dimensions subject to change without notice.

NOTICE: Suitable for Dry or Damp location.




Tools Needed



Preparation

- Shut off power to desired circuit before any work. Identify and prepare location for installation.
- Carefully unpack the fixture from its packaging and inspect product for defects due to shipping.

Fixture Mounting


- Note: Fixture ships with hook and chain system but can be mounted with chain, cable, or pendant (with Accessory Box).
 - Install chains on to v-hooks
 - Install hooks into holes on fixture ends.
 - Locate stable structure to hang fixture and securely attach chains.
 - Make wiring connections per wiring diagram.

Cable Mount (supplied by others)


- Install cables into holes on fixture ends.
- Locate stable structure to hang fixture and securely attach cable.
- Make wiring connections per wiring diagram





Pendant Mount


- Place pendant hanger on the fixture as shown.
- Align screw holes and bolt the bracket to the fixture using the provided hardware.
- Make wiring connections inside the pendant box per wiring diagram.
- Once the connections are made, attach both face plates to the mounting bracket using the provided hardware.





Surface Mount

- Place surface mount brackets on the fixture as shown.
- Align screw holes and bolt the bracket to the fixture using the provided hardware.
- Mark mounting hole locations on surface and install properly rated hardware.
- Make wiring connections inside the junction box per the wiring diagram.
- Once the connections are made, slip bracket keyholes over mounting hardware and secure hardware.





Wire Guard


- Align guard with bottom of fixture and snap into place.
- Secure with included screws.





Wiring Connections

- Connect fixture Black to Line wire
- Connect fixture White to Common/Neutral wire
- Connect fixture Green to Ground wire.
- Purple and Pink leads are for 0-10V dimming leads. Connect to low voltage wiring only.
- Yellow wires provide 12VDC output to power sensors or other controls requiring 12VDC power supply.
- Cap off any unused wiring.



With Sensor Socket

The product shall be considered defective only if 10% or more of the product's LED components fail. NICOR LED product warranty covers the following performance criteria: LED Light Output will be maintained above 70% of initial output; LED color temperature will not shift more than 200K in CCT; LED driver will operate within NICOR specifications; and the fixture finish, excluding natural aluminum or brass products, will not exhibit cracking, peeling, excessive fading, or corrosion during the warranty period. Exceptions apply as defined in NICOR's product specification sheets, which are incorporated by reference herein.

This limited warranty is provided to you, the purchaser of the product identified on Seller's invoice, as your exclusive remedy and applies only to NICOR products that have been purchased from an authorized NICOR Distributor; the product was new and in an unopened NICOR package at the time of installation; and the NICOR product was installed by a licensed electrician or under the supervision of a licensed electrician and used by consumers in the United States or Canada when accompanied with this warranty. This warranty extends only to the first consumer purchaser and is not transferable. A consumer wishing to invoke the terms of this limited warranty must first obtain a RGA number within 30 days of discovery of the defect, and return the product to NICOR for inspection. Once verified to be covered by this limited warranty, NICOR will, at its sole discretion, repair, replace, or refund the purchase price of any product that does not conform to this limited warranty. If NICOR, at its sole discretion, determines that the product should be repaired or replaced, this warranty is limited to the reasonable, customary, and necessary costs and expenses associated with the repair/replacement. This warranty requires that all repair/replacement estimates and costs, including but not limited to equipment rental (if any), and any other cost or expense to be incurred in the repair/replacement of the product, be approved in advance and in writing by NICOR.

FAILURE TO OBTAIN NICOR'S ADVANCE WRITTEN APPROVAL OF ALL REPAIR/REPLACEMENT COSTS AND EXPENSES IN WRITING SHALL VOID THIS LIMITED WARRANTY.
