

## **ASSEMBLY INSTRUCTIONS**



1. Place the two legs (7) together as shown in the above image.



 Slide the ring (10) over the legs (7) and align the holes. Connect the ring (10) to the legs with the screws and sleeves (3) and tighten.
 Repeat for the other holes.

#### ASSEMBLY INSTRUCTIONS CONT.



 Place the swivel plate (8) on top of legs and align holes. Use screw and nuts (4) to connect swivel plate (8) to legs. Tighten securely. Repeat for the remaining holes.



- Turn the stool over and secure the swivel plate to the bottom side of cushion (9) with 1/2 in. machine screws (5) as shown in the image above. Repeat for remaining holes.
- Turn stool right side up. If the stool legs are uneven, insert a shim (6) between the foot pad and the stool leg to level the stool.
