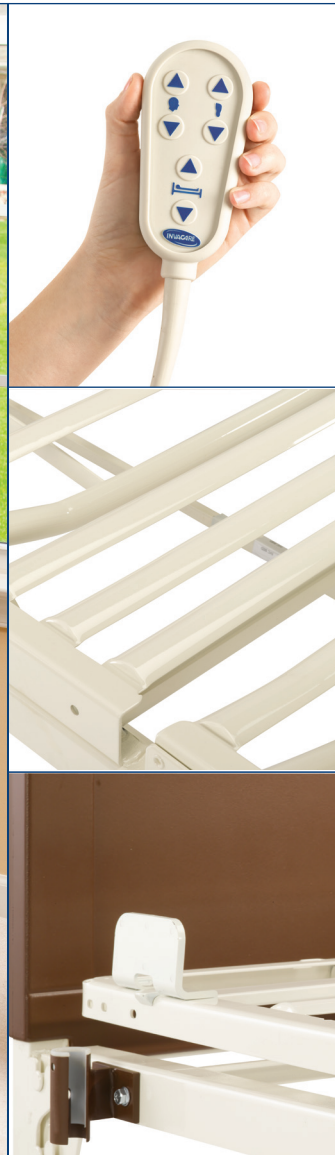

**Interchangeable Bed Ends** - Extra extensive travel range. Easy to clean and impact-resistant.

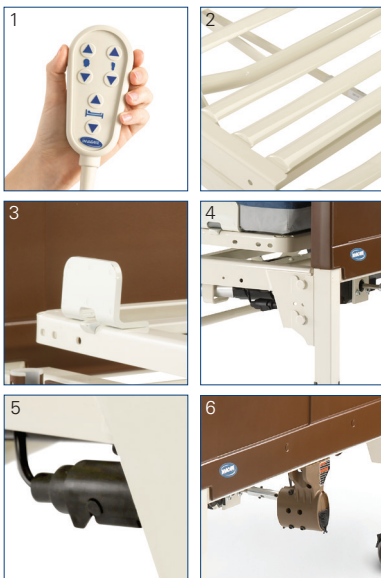
**Secure Mattress Keepers** - Securely position the mattress to prevent sliding.
