5. Fire-fighting measures

Suitable extinguishing media

Specific hazards arising from the chemical

Contents under pressure. Pressurized container may rupture when exposed to heat or flame. This product is a poor conductor of electricity and can become electrostatically charged. 6. Accidental release measures

Methods and materials for containment and cleaning up

Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep combustibles (wood, paper, oil, etc.) away from spilled material. The product is immiscible with water and will spread on the water surface. Prevent product from entering drains. Stop the flow of material, if this is without risk. 7. Handling and storage


