- RO membrane is a thin film composite (TFC) type.
- System is wall mountable with a stainless steel bracket design.
- System inlet plumbing connections are 1/4" quick disconnect type.
- System drain plumbing connections are 1/4" guick disconnect type.
- System outlet plumbing connections are 3/8" quick disconnect type.
  System incorporates an integrated 2 gallon (7.6 liter) water storage tank.
- System produces 75 gallons (284 liters) at 77°F (25°C) per 24 hour period.
- System minimum incoming water pressure of 50 psi (345 kPa) and a maximum of 100 psi (689 kPa) + 15%.

  exceeds 80 psi (552 kPa), you must install a pressure limiting valve. Contact a plumbing
  professional if you are uncertain how to check your water pressure.
- **Do not install** where water hammer conditions may occur. If water hammer conditions exist you must install a water hammer arrester. Contact a plumbing professional if you are uncertain how to check for this condition.
- The disposable filter cartridge **MUST** be replaced every 12 months, at the rated capacity or if a noticeable reduction in flow rate occurs.
