10. Stool service must be performed only by qualified repair personnel.


Service or maintenance performed by unqualified personnel could result in a risk of injury.

• Adjustable wrench • Hammer and block of wood or rubber mallet • slotted screwdriver

ASSEMBLY INSTRUCTIONS

1. Remove parts from box and inspect carefully for any damage that may have occurred during transit.
2. **MAKE SURE** the tray is on a firm surface with the wheels down. Insert the lifting unit (B) into the tool tray hole (C). The bigger end of the lifting unit (B) is the end that inserts into the tool tray hole (C). It might be necessary to seat the lifting unit (B). Do this by holding a block of wood over the top of the lifting unit and gently tapping with hammer to seat the lifting unit. **NOTE:** It might be easier to position the tray, wheels down, on the grass or a surface that is not smooth.
3. **ATTACH** the seat (A) to the lifting unit (B)
4. **TO RAISE** seat, stand next to stool. Lift handle, and release when seat is at the desired height.
6. **TO LOWER** seat, sit on the stool. Lift handle, and release when the seat is at the desired height.


