# **General Use Directions:**

- 3. Rinse off scrubbed areas with clean water.
- 4. Clean scrubber as necessary after use.

#### Scrubber Cleaning Instructions:

Cleaning scrubber provides multiple uses. Used and/or wornout scrubbers can be disposed of in regular kitchen trash.

Scrubbers can be rinsed with warm hot water or soaked in a cleaning solution to dissolve caked-on soil and grease.

- Spray or rinse off excess food debris from scrubber using a dish sprayer or sink faucet.
- Wash the scrubber in soapy water to remove any remaining food debris and grease. Remove imbedded food debris from scrubber by hand.
- 3. Rinse the scrubber with clean water. Make sure no food debris is left in the scrubber. Shake excess water from the scrubber and allow to air dry.
