Handling/Application Information

Application Examples

• 3M tape 469 is a high tack, high temperature double coated tissue tape which is light red in color for visible splices. The medium firm adhesive features good quick stick for high-speed flying splices on most grades of paper and excellent heat resistance for many high temperature drying ovens.

Application Techniques

- Bond strength is dependent upon the amount of adhesive-to-surface contact developed. Firm application pressure helps develop better adhesive contact and improve bond strength.
- To obtain optimum adhesion, the bonding surfaces must be clean, dry, and well unified.
 Ideal tape application temperature range is 70°F to 100°F (21°C to 38°C). Initial tape application to surfaces at temperatures below 50°F (10°C) is not recommended because the adhesive becomes too firm to adhere readily. However, once properly applied, low temperature holding is generally satisfactory.

Storage and Shelf Life

Store in original cartons at 70°F (21°C) and 50% relative humidity. If stored under proper conditions, product retains its performance and properties for 24 months from date of manufacture.
