The Benchmark USA Street Vendor Popcorn Machines models 11040, 11060, and 11080 as manufactured by Winco®, Lodi, NJ 07644

The Street Vendor Popcorn Machine model 11040 shall have a 4 oz kettle capacity be rated at 1040W, 120V-60Hz, model 11060 shall have a 6 oz kettle capacity be rated at 1240W, 120V-60Hz, and 11080 shall have a 8 oz kettle capacity be rated at 1490W. Kettles are constructed with a thick 20 mil non-stick coating. All units shall be supplied with a NEMA 5-15P plug.

Units cabinet shall be constructed of a stainless steel, aluminum, powder coated painted accent panels with tempered glass panels on front and side and clear plexiglass doors at rear. Units are supplied with easy to use, simple two-switch operation, 50 Watt warmer light (bulb included), old-maid drawer to catch unpopped kernels,

CE certified and ETL listed for safety (Canada & US) and sanitation.

Warranty consists of one year parts and labor.
