Luminaire must be connected to a wiring system with an equipment-grounding conductor.


To avoid explosion:

What's In The Box




One (1) Vela

Tools Needed

A screwdriver, drill, a pair of wire strippers, and 4 fasteners appropriate for the mounting surface will be needed to install the Vela.



- 1** Carefully unpack fixture from packaging and inspect for any damage caused in shipping.




- 2** Turn off power using appropriate switch/breaker.


- 3** Locate desired positioning for the fixture on the mounting surface.

Mounting to j-box

- 4a** Attach the mounting plate to the junction box and secure with screws.




- 4b** Hang the fixture onto the mounting plate, swing up into place, and tighten screws.




Mounting to ceiling/conduit


- 5a** Loosen screws and remove the lens and reflector (DO NOT TOUCH LEDS)



- 5b** Drill out holes for mounting.



- 5c** Remove 1/2" plug from the direction conduit will feed.



- 5d** Use the EVA gasket to cover the 3/4" threaded hole on the pack plate.


- 5e** Attach fixture with (4) four fasteners.

- 5f** Connect wiring as shown in wiring diagram.


- 5g** Replace the reflector and the lens.

Mounting with a pendant

- 6a** Remove mounting plate by loosening the screw. (NOT NEEDED FOR PENDANT MOUNT)



- 6b** Remove plug and twist in pendant conduit (3/4" SIZE OF THREAD AND HOLE) and follow wiring diagram




- 7** Check that fixture is firmly attached to mounting surface.


- 8** Turn power on (or energize fixture) and verify that the fixture is lit.

IMPORTANT: To weather-proof your outdoor installation, be sure to seal all mounting points, wire inlets, and penetrations (Conduit, Plugs, etc.) with silicone sealant.
