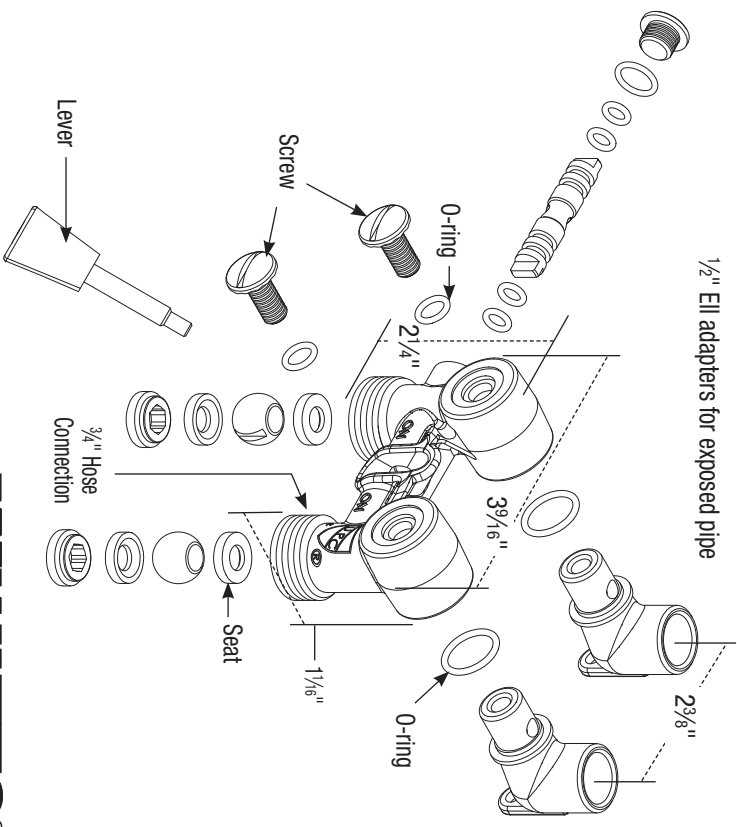
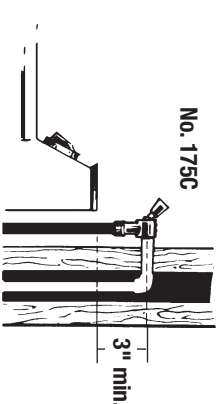

4. Pipe connections are 2 3/8" (60mm) on center.

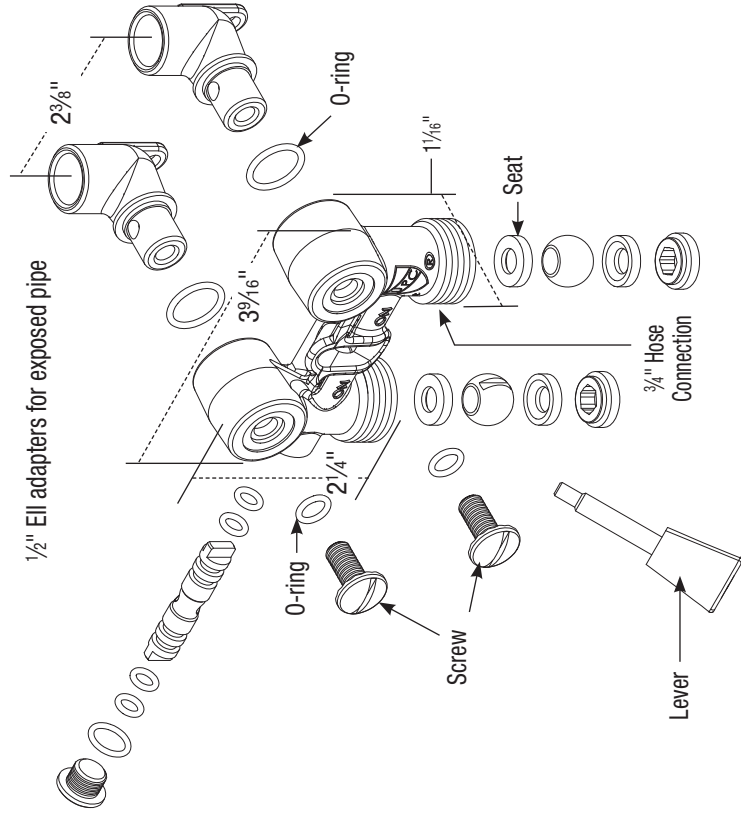
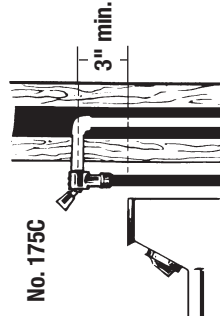
