Exclusive Slat Deck Design – Provides a comfortable sleep surface, allows for improved infection control and helps reduce wear and tear on the mattress.

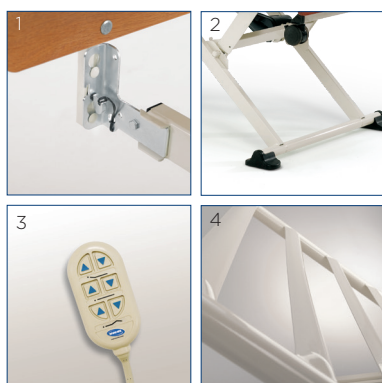
Ergonomic Hand Pendant – Water-resistant¹, sealed hand pendant designed to fit comfortably in the resident's hand.
