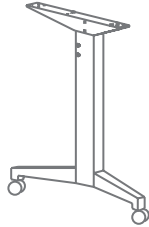

- Durable steel construction with non-porous surface is easy to clean and disinfect



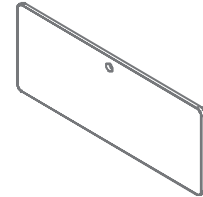
