

- Do not move or dolly the vehicle while it is on the jack.
- Lift only on areas of the vehicle as specified by the vehicle manufacturer.
- No alterations shall be made to this product.
- Failure to heed these markings may result in serious personal injury and/or property damage.

SETUP, OPERATION & PREVENTATIVE MAINTENANCE

STEELMAN®

- Prior to each use, visual inspection (see pg. 6) shall be made to the device by checking for abnormal conditions, such as cracked welds, leaks, and damaged, loose, or missing parts.
- Consult the vehicle owner's manual to determine the location of lift points.
- Be sure to set the vehicle in park with the emergency brake on and wheels securely chocked.
- . Be sure that the vehicle and the jack are on a hard and level surface.

ASSEMBLY

- Insert the bottom end of the T-handle into handle fork and securely tighten the bolt.
- Slightly turn the release valve while inserting to ensure the proper seating in the U-joint.

- Turn the release valve knob, located on top of the T-handle, clockwise to the closed position.
- Position the jack under the specified lift point.
- Press the foot pedal down to quickly lift the saddle to the contact point.
- Begin lifting by pumping the T-handle up and down.
- Remove the jack stands. Do not get under or let anyone get under the vehicle while lowering.
- Turn the release valve located on top of the T-handle slowly counter-clockwise to lower the vehicle to the ground.

- Turn the release valve knob, located on top of the T-handle, clockwise to the closed position.
- Position the jack under the specified lift point.
- Press the foot pedal down to quickly lift the saddle to the contact point.
- Begin lifting by pumping the T-handle up and down.
- Remove the jack stands. Do not get under or let anyone get under the vehicle while lowering.
- Turn the release valve located on top of the T-handle slowly counter-clockwise to lower the vehicle to the ground.

A MAINTENANCE

NOTICE: Use high grade hydraulic oil only. Never use brake fluid, motor oil, transmission fluid, turbine oil or any other fluids. ISO-VG22 or equivalent hydraulic oil is recommended.

CHECK AND REFILL OIL

- With the jack in the fully lowered, level position, if unit cover is provided, remove unit cover, then remove oil filler plug.
- Proper oil level should be just covering inner cylinder as seen from the oil filler plug hole.

SETUP, OPERATION & PREVENTATIVE MAINTENANCE

A MAINTENANCE (CONTINUED)

- Do not overfill. Always fill with new, clean hydraulic jack oil as recommended above.
- Reinstall oil filler plug, then reinstall unit cover.

LUBRICATION AND CLEANING

• Periodically clean and lubricate all moving parts and pivot points.

AIR VENTING PROCEDURES

- With the jack in the fully lowered position, release valve open, remove oil filler plug.
- Pump the handle rapidly several times. Reinstall oil filler plug.
- Turn the handle/release valve clockwise to the closed position.
- Pump the handle until the lift arm reaches maximum height and continue to pump several times to remove trapped air in the system.
- Turn the handle/release valve counter-clockwise in one full turn and lower lift arm to the lowest position. Use force on saddle if necessary.
- Carefully and slowly loosen oil filler plug to release pressurized air.
- Repeat above steps until trapped air is completely vented.

DAMAGED EQUIPMENT

Any jack that appears to be damaged in any way, is found to be worn, or operates abnormally **SHALL BE REMOVED FROM SERVICE UNTIL REPAIRED**. It is recommended that necessary repairs be made by a manufacturer's or supplier's authorized repair facility if repairs are permitted by the manufacturer or supplier.

ALTERATIONS

Because of potential hazards associated with this type of equipment, no alterations shall be made to the product.

ATTACHMENTS AND ADAPTERS

Only attachments and/or adapters supplied by the manufacturer shall be used.

- Visual inspection shall be made before each use of the device by checking for abnormal conditions, such as cracked welds, leaks, and damaged, loose, or missing parts.
- Other inspections shall be made per product operating instructions.
- This device shall be inspected immediately if the device is believed to have been subjected to an abnormal load or shock. It is recommended that this inspection be made by a manufacturer's or supplier's authorized repair facility.
- Owners and/or operators should be aware that repair of this equipment may require specialized knowledge and facilities. It is recommended that an annual inspection of the product be made by a manufacturer's or supplier's authorized repair facility and that any defective parts, decals, or safety labels or signs be replaced with manufacturer's or supplier's specified parts.



A TROUBLESHOOTING

Jack will not lift the load.	 Release valve not tightly closed. Low oil level. Defective or worn internal parts. Load exceeds maximum allowance. 	 Tighten release valve. Check and add oil. Follow "Check and Refill Oil" instructions on page 3-4 Discontinue use and contact a local repair center. Use a higher capacity jack. 	
Jack will not hold the load.	 Release valve not tightly closed. Power unit malfunction 	 Tighten release valve. Discontinue use and contact a local repair center. 	
Jack will not descend to minimum height, or will not remain in lowered position.	1. Air trapped in system. 2. Reservoir oil overfilled.	 Vent air out of system. Follow "Air Venting Procedures" above. Check and ensure proper oil level. Follow "Check and Refill Oil" instructions on pgs 3-4 	
Jack will not lift to max height.	1. Low oil level.	1. Check and ensure proper oil level. Follow "Check and Refill Oil" instructions above.	
Jack will not function properly after tried solution.	1. Internal malfunction or structural damage.	1. Stop usage and contact an autorized repair center.
