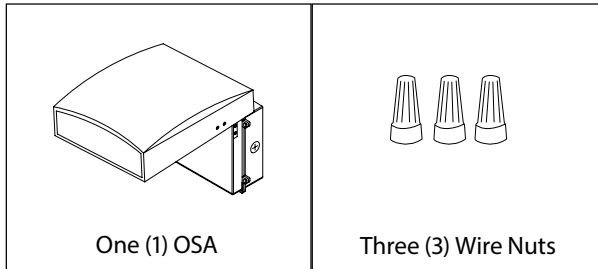




WARNING

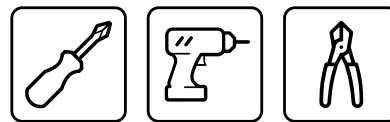

- All parts must be used as indicated in the instructions.
- The use of accessory equipment not recommended by the manufacturer may cause an unsafe condition.
- To maintain Wet Location Rating, ONLY use UL approved wet location junction boxes and conduit.
- Operating temperature: -40°C to 40°C

What's In The Box



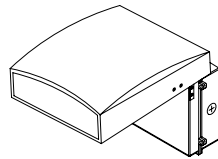
Tools Needed

A screwdriver, drill, a pair of wire strippers, and 3-4 ct. fasteners appropriate for the mounting surface will be needed to install the Octans.



Make sure all power is turned off before beginning installation

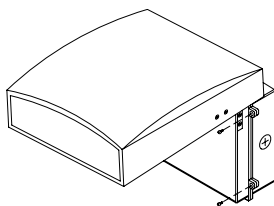
- 1** Carefully unpack fixture from packaging and inspect for any damage caused in shipping.



- 2** Ensure that power is turned off power at appropriate circuit breaker.

- 3** Locate desired positioning for the fixture on the mounting surface.

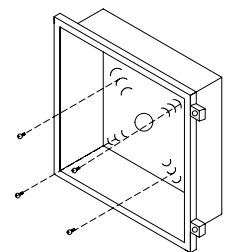
- 4** Open fixture to 90° position and remove the (2) two cover screws to open the fixture on the hinge.



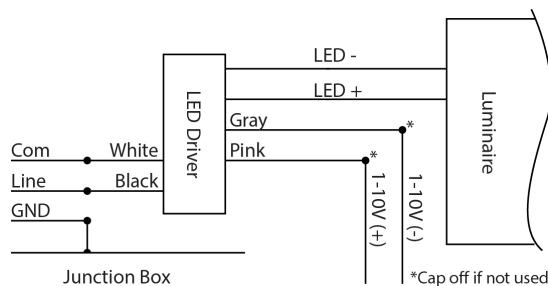
- 5** Remove the back plate and drill out the holes for mounting.

- 6** Attach the back plate to the recessed J-Box

IMPORTANT: Alternate conduit method: remove the conduit plugs and attach the threaded conduit for wiring to the back plate (3/4" conduit)

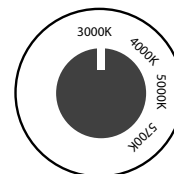


- 7** Connect wiring as shown in Wiring Diagram. Cap off dimming wires if not used.

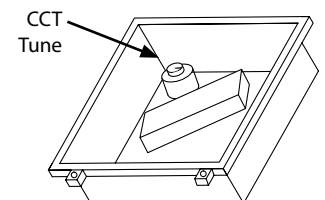


- 8** For Single CCT Version: Move to step 10.

For CCT Selectable Version: The CCT selection switch is located on the back plate, wired into the driver. To select CCT, turn switch to desired setting. It is recommended to adjust CCT with the power off.

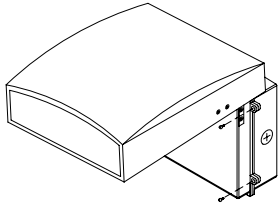


CCT Tune Switch

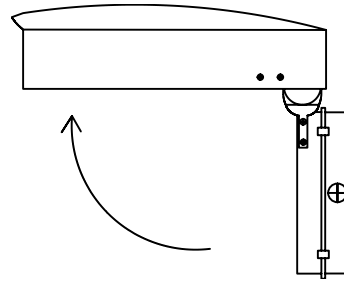


9 Firmly reattach cover with (2) two screws.

Check that the fixture is firmly attached to the mounting surface.



10 Manually adjust fixture position to desired angle.



11 Energize fixture and verify that the fixture is lit.

12 Loosen screws on bottom of mounting back box to allow for moisture wicking.

This limited warranty is provided to you, the purchaser of the product identified on Seller's invoice, as your exclusive remedy and applies only to NICOR products that have been purchased from an authorized NICOR Distributor; the product was new and in an unopened NICOR package at the time of installation; and the NICOR product was installed by a licensed electrician or under the supervision of a licensed electrician and used by consumers in the United States or Canada when accompanied with this warranty. This warranty extends only to the first consumer purchaser and is not transferable. A consumer wishing to invoke the terms of this limited warranty must first obtain a RGA number within 30 days of discovery of the defect, and return the product to NICOR for inspection. Once verified to be covered by this limited warranty, NICOR will, at its sole discretion, repair, replace, or refund the purchase price of any product that does not conform to this limited warranty. If NICOR, at its sole discretion, determines that the product should be repaired or replaced, this warranty is limited to the reasonable, customary, and necessary costs and expenses associated with the repair/replacement. This warranty requires that all repair/replacement estimates and costs, including but not limited to equipment rental (if any), and any other cost or expense to be incurred in the repair/replacement of the product, be approved in advance and in writing by NICOR. FAILURE TO OBTAIN NICOR'S ADVANCE WRITTEN APPROVAL OF ALL REPAIR/REPLACEMENT COSTS AND EXPENSES IN WRITING SHALL VOID THIS LIMITED WARRANTY.
