PROPANE GAS WARNINGS

▲ DANGER

IF YOU SMELL GAS:

- SHUT OFF GAS TO THE APPLIANCE.
- EXTINGUISH ANY OPEN FLAME.
- OPEN LID.
- IF ODOR CONTINUES, KEEP AWAY FROM THE APPLIANCE AND IMMEDIATELY CALL YOUR GAS SUPPLIER OR YOUR FIRE DEPARTMENT.

A DANGER

NEVER OPERATE THIS APPLIANCE:

- UNATTENDED.
- WITHIN 3.0 M (10 FT) OF ANY STRUCTURE, COMBUSTIBLE MATERIAL OR OTHER GAS CYLINDER.
- WITHIN 7.5 M (25 FT) OF ANY FLAMMABLE LIQUID.

FAILURE TO FOLLOW THESE INSTRUCTIONS COULD RESULT IN FIRE OR EXPLOSION WHICH COULD CAUSE PROPERTY DAMAGE, PERSONAL INJURY OR DEATH.

- 1. ENSURE THE GAS CYLINDER IS PURCHASED BY A REPUTABLE SUPPLIER. AN INCORRECTLY FILLED OR AN OVERFILLED GAS CYLINDER CAN BE DANGEROUS. THE OVERFILLED CONDITION COMBINED WITH THE WARMING OF THE GAS CYLINDER (A HOT SUMMER DAY, GAS CYLINDER LEFT IN THE SUN, ETC.) CAN CAUSE LP GAS TO BE RELEASED SINCE THE TEMPERATURE INCREASE CAUSES GAS TO EXPAND. GAS RELEASED FROM THE CYLINDER IS FLAMMABLE AND CAN BE EXPLOSIVE.
- 2. DO NOT USE AN LP GAS CYLINDER IF IT HAS A DAMAGED VALVE OR SHOWS SIGNS OF DENTS, GOUGES, BULGES, FIRE DAMAGE, CORROSION, LEAKAGE, EXCESSIVE RUST, OR OTHER FORMS OF VISUAL EXTERNAL DAMAGE; IT MAY BE HAZARDOUS AND SHOULD BE CHECKED IMMEDIATELY BY A LIQUID PROPANE SUPPLIER.

IF YOU SEE, SMELL, OR HEAR THE HISS OF GAS ESCAPING FROM THE CYLINDER, DO NOT ATTEMPT TO LIGHT APPLIANCE. EXTINGUISH ANY OPEN FLAME. DISCONNECT FROM FUEL SUPPLY.

- 3. DO NOT CONNECT OR DISCONNECT THE GAS CYLINDER WHILE THE UNIT IS IN USE OR IS STILL HOT. WHEN CAMP STOVE IS NOT IN USE, ENSURE SUPPLY CYLINDER IS TURNED TO OFF AND DISCONNECT THE GAS CYLINDER. NEVER MOVE OR TRANSPORT THE UNIT WHILE THE GAS CYLINDER IS ATTACHED. DO NOT STORE A SPARE LP GAS CYLINDER UNDER OR NEAR THE APPLIANCE.
- 4. PARTS SEALED BY MANUFACTURER SHALL NOT BE MANIPULATED BY THE USER. DO NOT MOVE THE APPLIANCE DURING USE. TURN OFF THE GAS SUPPLY AT THE GAS CYLINDER AFTER USE. DO NOT MODIFY THE APPLIANCE. THE REPLACEMENT HOSE ASSEMBLY SHALL BE THAT SPECIFIED BY THE MANUFACTURER.
- 5. OPERATE THIS APPLIANCE USING LIQUEFIED PETROLEUM ONLY, WHICH IS ALSO SPECIFIED ON THE RATING LABEL ON THE UNIT. DO NOT ATTEMPT TO OPERATE YOUR CAMP STOVE ON OTHER GASES. DO NOT ATTEMPT TO CONVERT THIS LP UNIT TO NATURAL GAS. FAILURE TO FOLLOW THIS WARNING COULD LEAD TO FIRE, BODILY HARM, AND WILL VOID YOUR WARRANTY.
- 6. ALWAYS CHECK FOR GAS LEAKS WHEN YOU CONNECT AND DISCONNECT THE REGULATOR TO THE GAS CYLINDER, ESPECIALLY AFTER A PERIOD OF STORAGE (FOR EXAMPLE, OVER WINTER). CHECK ALL CONNECTIONS FOR LEAKS WITH A SOAPY WATER SOLUTION AND BRUSH. NEVER USE AN OPEN FLAME TO CHECK FOR LEAKS.

DANGERS AND WARNINGS

1. A MINIMUM CLEARANCE OF 3 M (10 FEET) FROM COMBUSTIBLE CONSTRUCTIONS TO ALL SIDES OF THE UNIT MUST BE MAINTAINED. DO NOT USE THIS APPLIANCE INDOORS OR IN AN ENCLOSED, UNVENTILATED AREA. THIS APPLIANCE MUST NOT BE PLACED UNDER OVERHEAD COMBUSTIBLE CEILING OR OVERHANG, INCLUDING ON OR UNDER ANY APARTMENT, OR CONDOMINIUM BALCONY OR DECK. USE THE BURNER ON A STABLE LEVELED NON-COMBUSTIBLE SURFACE AND IN AN AREA CLEAR OF COMBUSTIBLE MATERIALS. AN ASPHALT SURFACE (BLACKTOP) MAY NOT BE ACCEPTABLE FOR THIS PURPOSE.

SHOULD A GREASE FIRE OCCUR, TURN THE CAMP STOVE OFF UNTIL THE FIRE IS OUT. DO NOT THROW WATER ON. DO NOT TRY TO SMOTHER THE FIRE. USE OF AN ALL-CLASS (CLASS ABC) APPROVED FIRE EXTINGUISHER IS VALUABLE TO KEEP ON SITE. IF AN UNCONTROLLED FIRE DOES OCCUR, CALL THE FIRE DEPARTMENT.

2. THIS OUTDOOR CAMP STOVE IS NOT INTENDED FOR INSTALLATION IN/ON RECREATION VEHICLES OR BOATS.

NEVER USE THIS APPLIANCE IN AN ENCLOSED SPACE, SUCH AS A CAMPER, TENT, CAR, BOAT OR HOME. THIS APPLIANCE IS NOT INTENDED FOR AND SHOULD NEVER BE USED AS A HEATER.

- 3. THIS APPLIANCE IS NOT RECOMMENDED FOR CHILDREN, PERSONS WITH REDUCED PHYSICAL, SENSORY OR MENTAL CAPABILITIES, OR LACK OF EXPERIENCE AND KNOWLEDGE, UNLESS THEY ARE UNDER DIRECT SUPERVISION OR INSTRUCTION BY A PERSON RESPONSIBLE FOR THEIR SAFETY. - 5. PARTS OF THE CAMP STOVE MAY BE VERY HOT, AND SERIOUS INJURY MAY OCCUR. KEEP YOUNG CHILDREN AND PETS AWAY WHILE IN USE. DO NOT TOUCH HOT SURFACES. USE HEAT-RESISTANT GLOVES, LONG-HANDLED TONGS, OR COOKING MITTS AT ALL TIMES, SINCE THE CAMP STOVE WILL BECOME VERY HOT.
- 6. DO NOT OBSTRUCT THE FLOW OF COMBUSTION AND VENTILATION AIR TO THIS APPLIANCE. KEEP THE BURNER TUBE AND PORTHOLES CLEAN AND FREE FROM DEBRIS. CLEAN BEFORE USE. REGULAR CARE AND MAINTENANCE IS REQUIRED TO PROLONG THE LIFESPAN OF YOUR UNIT. KEEP THE FUEL SUPPLY HOSE AWAY FROM ANY HEATED SURFACE(S).
- 7. CLEAN AND INSPECT THE GAS REGULATOR BEFORE EACH USE OF THE OUTDOOR COOKING GAS APPLIANCE. REPLACE THE GAS REGULATOR PRIOR TO BEING USED IF THERE IS EVIDENCE OF EXCESSIVE ABRASION OR WEAR.

CARBON MONOXIDE

CARBON MONOXIDE IS A COLORLESS, ODORLESS, TASTELESS GAS PRODUCED BY BURNING GAS, WOOD, PROPANE, CHARCOAL OR ANY OTHER FUELS. CARBON MONOXIDE REDUCES THE BLOOD'S ABILITY TO CARRY OXYGEN. LOW BLOOD OXYGEN LEVELS CAN RESULT IN HEADACHES, DIZZINESS, WEAKNESS, NAUSEA, VOMITING, SLEEPINESS, CONFUSION, LOSS OF CONSCIOUSNESS OR DEATH. FOLLOW THESE GUIDELINES TO PREVENT THIS COLORLESS, ODORLESS GAS FROM POISONING YOU, YOUR FAMILY, OR OTHERS:





DISCARD ALL PACKAGING MATERIALS FROM INSIDE AND OUTSIDE OF THE UNIT BEFORE ASSEMBLY, THEN REVIEW AND INSPECT ALL PARTS BY REFERENCING THE PARTS LIST. IF ANY PART IS MISSING OR DAMAGED, DO NOT ATTEMPT TO ASSEMBLE. SHIPPING DAMAGE IS NOT COVERED UNDER WARRANTY. CONTACT CUSTOMER CARE FOR PARTS: MONDAY THROUGH SUNDAY, 4 A.M. – 8 P.M. PST (EN/FR/ES).

TOOLS REQUIRED FOR ASSEMBLY: PHILLIPS SCREWDRIVER. TOOLS NOT INCLUDED.



ASSEMBLY INSTRUCTIONS


PLACE A PIECE OF CARDBOARD ON THE FLOOR TO PREVENT SCRATCHING THE UNIT AND PARTS DURING ASSEMBLY.




Turn over the Stove Body so it lies flat-side down on the cardboard. Push down the Locking Pin to release each Support Leg. Extend each of the four Support Legs until the Locking Pins lock at full extension.




Turn over the Stove Body so it stands on the Support Legs. Install Bracket D to the left side of the Stove Body using four screws, as shown.




On the front Support Legs only, tighten the Support Leg fixing screws to lock all Support Legs in place.




Mount Bracket A and Bracket B to the left side of the Side Table (handle faces the front) using two screws in each Bracket, as shown.




Fasten the Support Frame to the Side Table using two step screws. To secure the Support Frame in expanded position, swing the Locking Plate onto the Locking Pin.



Lift the Wind Shield upright and expand the Wind Shield Side Wings. Place the tabs of the Wind Shield Side Wings into the small tab openings near the front two corners of the Stove Body top.



Fasten the Side Table to the Stove Body using four screws.



If ground is uneven, rotate the bottom half of each Support Leg to adjust the height. Adjustment variant is up to 1.5 inches / 38 mm. Assembly of unit is now complete.

GAS CYLINDER REQUIREMENTS

THE CAMP STOVE IS SET AND TESTED WITH LIQUID PROPANE (LP) GAS ONLY. THE REGULATOR SUPPLIED IS SET FOR 27.94 CM (11 INCH) WATER COLUMN (WC) AND IS FOR USE WITH LP GAS ONLY. THE FACTORY-SUPPLIED REGULATOR AND HOSE MUST BE USED WITH A 9 KG (20 LB) LP GAS TANK. CONTACT YOUR GAS SUPPLIER FOR A SPECIAL REGULATOR FOR BULK GAS THAT FUELS OTHER APPLIANCES.

CAUTION: IT IS IMPORTANT TO INSPECT THE FULL LENGTH OF THE GAS LINE HOSE. IF IT IS EVIDENT THERE IS EXCESSIVE ABRASION OR WEAR, OR THE HOSE IS CUT, THE HOSE MUST BE REPLACED PRIOR TO THE APPLIANCE BEING USED.

THE LP-GAS SUPPLY CYLINDER TO BE USED MUST BE CONSTRUCTED AND MARKED IN ACCORDANCE WITH THE SPECIFICATIONS FOR LP-GAS CYLINDERS, U.S. DEPARTMENT OF TRANSPORTATION (DOT) OR THE STANDARD FOR CYLINDERS, SPHERES AND TUBES FOR THE TRANSPORTATION OF DANGEROUS GOODS, CAN/CSA-B339. CYLINDER SYSTEM MUST BE ARRANGED FOR VAPOR WITHDRAWAL.


- 1. DO NOT STORE A SPARE LP GAS CYLINDER UNDER OR NEAR THIS APPLIANCE.
- 2. NEVER FILL THE GAS CYLINDER BEYOND 80 PERCENT FULL.
- 3. IF THE INFORMATION IN 1) AND 2) IS NOT FOLLOWED EXACTLY A FIRE CAUSING DEATH OR SERIOUS INJURY MAY OCCUR.
- 4. PLACE DUST CAP ON CYLINDER VALVE OUTLET WHENEVER THE CYLINDER IS NOT IN USE. ONLY INSTALL THE TYPE OF DUST CAP ON THE CYLINDER VALVE OUTLET THAT IS PROVIDED WITH THE CYLINDER VALVE. OTHER TYPES OF CAPS OR PLUGS MAY RESULT IN LEAKAGE OF PROPANE.
- 5. THE LP GAS CYLINDER USED MUST HAVE A COLLAR TO PROTECT THE GAS CYLINDER VALVE.
- 6. ALWAYS KEEP THE LP CYLINDER AT 90 DEGREES (UPRIGHT) ORIENTATION TO PROVIDE VAPOR WITHDRAWAL.

NOTE: THE NORMAL FLOW OF GAS THROUGH THE REGULATOR AND HOSE ASSEMBLY CAN CREATE A HUMMING NOISE. A LOW VOLUME OF NOISE IS PERFECTLY NORMAL AND WILL NOT INTERFERE WITH OPERATION OF THE CAMP STOVE. IF HUMMING NOISE IS LOUD AND EXCESSIVE YOU MAY NEED TO PURGE AIR FROM THE GAS LINE OR RESET THE REGULATOR EXCESS GAS FLOW DEVICE. THIS PURGING PROCEDURE SHOULD BE DONE EVERY TIME A NEW LP GAS TANK IS CONNECTED TO YOUR CAMP STOVE.

CONNECTING THE GAS CYLINDER

IMPORTANT: IF THE MANIFOLD REQUIRES A CONNECTOR, FOLLOW THE CONNECTOR INSTALLATION INSTRUCTIONS PRIOR TO CONNECTING THE UNIT TO A GAS CYLINDER.

- 1. BEFORE CONNECTING, ENSURE THERE IS NO DEBRIS CAUGHT IN THE HEAD OF THE LP GAS CYLINDER, HEAD OF THE REGULATOR VALVE, OR IN THE HEAD OF THE BURNER AND BURNER PORTS.
- 2. CONNECT THE TUBE LINE TO THE MANIFOLD BY TURNING THE KNOB CLOCKWISE UNTIL IT STOPS. MAKE SURE THAT THE TUBE IS NOT TWISTED IN ANY WAY.
- 3. PLACE A GAS CYLINDER NEXT TO THE CAMP STOVE ON THE RIGHT SIDE. MAKE SURE THE GAS CYLINDER VALVE IS IN THE CLOSED POSITION. IT IS IMPORTANT TO ENSURE THE GAS CYLINDER IS COMPLETELY UPRIGHT, AS IT IS UNSAFE TO OPERATE THE CAMP STOVE IF THE GAS CYLINDER IS NOT PROPERLY LEVEL OR ON A STABLE SURFACE.
- 4. ENSURE THE CONTROL KNOBS ON THE CAMP STOVE ARE COMPLETELY CLOSED BY TURNING THE KNOB CLOCKWISE TO THE "OFF" POSITION.
- 5. REMOVE THE PROTECTIVE CAPS FROM THE REGULATOR VALVE OPENING AND THE TOP OF THE GAS CYLINDER. SAVE THE CAPS.
- INSERT THE GAS CYLINDER VALVE INTO THE THREADED OPENING OF THE REGULATOR VALVE. TURN THE QUICK COUPLING NUT CLOCKWISE UNTIL FIRM. HAND-TIGHTEN ONLY.
- 7. GAS CYLINDER IS NOW INSTALLED. PERFORM A LEAK TEST.



WARNING: SHUT OFF THE GAS CYLINDER IF YOU SMELL GAS. ATTEMPT TO RE-INSTALL THE GAS CYLINDER TO ENSURE THAT TUBE IS CONNECTED PROPERLY. PERFORM A LEAK TEST.

NOTE: THE NORMAL FLOW OF GAS THROUGH THE REGULATOR AND HOSE ASSEMBLY CAN CREATE A HUMMING NOISE. A LOW VOLUME OF NOISE IS PERFECTLY NORMAL AND WILL NOT INTERFERE WITH OPERATION OF THE CAMP STOVE. IF HUMMING NOISE IS LOUD AND EXCESSIVE YOU MAY NEED TO PURGE AIR FROM THE GAS LINE OR RESET THE REGULATOR EXCESS GAS FLOW DEVICE. THIS PURGING PROCEDURE SHOULD BE DONE EVERY TIME A NEW GAS CYLINDER IS CONNECTED TO YOUR CAMP STOVE.

PREPARATION FOR USE – LEAK TESTING

A LEAK TEST IS USED TO DETERMINE THE INTEGRITY OF A SEAL. BEFORE USING YOUR CAMP STOVE, PERFORM A LEAK TEST ON THE CONNECTION BETWEEN THE REGULATOR AND THE GAS CYLINDER TO REDUCE THE RISK OF SERIOUS BODILY INJURY OR DEATH FROM FIRE OR EXPLOSION. A LEAK TEST SHOULD BE PERFORMED A MINIMUM OF ONCE A SEASON, AS WELL AS:

- BEFORE LIGHTING YOUR CAMP STOVE FOR THE FIRST TIME,
- EVERY TIME THE GAS CYLINDER HAS BEEN CHANGED,
- AFTER TRAVEL, ESPECIALLY OVER ROUGH OR BUMPY ROADS,
- AFTER A PROLONGED PERIOD OF STORAGE OR NON-USE.

HOW TO PERFORM A LEAK TEST

BEFORE YOU USE THE BURNER FOR THE FIRST TIME, AND ALSO PERIODICALLY, CHECK THE WHOLE SYSTEM FOR LEAKS FOLLOWING THE PROCEDURE LISTED BELOW. ALTERNATIVELY, IF THE SMELL OF GAS IS DETECTED AT ANYTIME DURING USE OF THE UNIT, TURN OFF GAS SUPPLY AND IMMEDIATELY CHECK THE ENTIRE SYSTEM FOR LEAKS.

LEAK TEST PROCEDURE

- 1. PREPARE A SOAPY SOLUTION IN A 30/70% PROPORTION OF DISH LIQUID DETERGENT AND WATER.
- 2. MAKE SURE ALL CONTROL KNOBS ARE AT THE OFF POSITION.
- 3. OPEN GAS CYLINDER VALVE.
- 4. USING A SPRAY BOTTLE OR APPLICATOR BRUSH, APPLY THE SOLUTION TO THE FITTINGS, ALL CONNECTIONS AND GAS HOSES. FOR THE INITIAL LEAK TEST, MAKE SURE THE LP CYLINDER IS FULL.
- 5. FORMATION OF BUBBLES INDICATE A LEAK. IF A LEAK IS IDENTIFIED, CLOSE GAS CYLINDER VALVE, RE-TIGHTEN LOOSE FITTINGS AND TEST AGAIN. IF LEAK PERSISTS OR REQUIRES REPLACEMENT OF A PART, CONTACT YOUR RESELLER OR A QUALIFIED GAS TECHNICIAN.

ONLY THOSE PARTS RECOMMENDED BY THE MANUFACTURER SHOULD BE USED ON THIS APPLIANCE. SUBSTITUTION WILL VOID THE WARRANTY. DO NOT USE THIS APPLIANCE UNTIL ALL CONNECTIONS HAVE BEEN CHECKED AND DO NOT LEAK.

DISCONNECTING THE GAS CYLINDER


- 1. TURN ALL CONTROL KNOBS TO "OFF" POSITION ON THE CAMP STOVE. ENSURE THE REGULATOR VALVE ON THE GAS CYLINDER IS COMPLETELY CLOSED BY TURNING THE KNOB TO THE CLOSED POSITION.
- 2. TURN THE QUICK COUPLING NUT COUNTER-CLOCKWISE (BY HAND) TO DISCONNECT FROM THE REGULATOR VALVE OPENING. REPLACE THE PROTECTIVE CAPS ON THE REGULATOR VALVE OPENING AND THE TOP OF THE GAS CYLINDER FOR STORAGE (IF NOT EMPTY).

WARNING: IF STORING THE UNIT INDOORS, LEAVE THE GAS CYLINDER OUTDOORS. DO NOT FOLD UP OR TRANSPORT UNIT WITH GAS CYLINDER ATTACHED. THE CYLINDER MAY LOOSEN OFF THE VALVE AND CAUSE A GAS LEAK, POSSIBLY RESULTING IN AN EXPLOSION, FIRE, OR SEVERE BODILY HARM. DISCONNECT GAS CYLINDER FIRST BEFORE TRAVEL OR STORAGE.

AUTOMATIC LIGHTING PROCEDURE

WITH ALL OUTDOOR APPLIANCES, OUTSIDE WEATHER CONDITIONS PLAY A BIG PART IN THE PERFORMANCE OF YOUR UNIT AND THE COOKING TIME NEEDED TO PREPARE YOUR MEALS. ALL THIESSENS UNITS SHOULD KEEP A MINIMUM CLEARANCE OF 3 M (10 FEET) FROM COMBUSTIBLE CONSTRUCTIONS, AND THIS CLEARANCE MUST BE MAINTAINED WHILE THE UNIT IS OPERATIONAL. THIS APPLIANCE MUST NOT BE PLACED UNDER OVERHEAD COMBUSTIBLE CEILING OR OVERHANG. KEEP YOUR UNIT IN AN AREA CLEAR FROM COMBUSTIBLE MATERIALS, OR OTHER FLAMMABLE VAPORS AND LIQUIDS.

- 1. OPEN WIND SHIELD PANELS DURING LIGHTING.
- 2. SET ALL CONTROL KNOBS TO THE "OFF" POSITION.
- 3. OPEN THE CYLINDER/GAS VALVE ACCORDING TO THE OPERATING INSTRUCTIONS ON TANK.
- 4. PUSH IN THE REGULATOR KNOB AND TURN COUNTER-CLOCKWISE TO HIGH UNTIL YOU HEAR A "CLICK" SOUND TO INDICATE A SPARK FROM THE IGNITER, AND LOOK FOR FLAME TO ENSURE THE BURNER IS LIT.
- 5. AFTER THE BURNER HAS CAUGHT FIRE, YOU ARE READY TO ENJOY YOUR CAMP STOVE AT YOUR DESIRED TEMPERATURE!



NOTE: DO NOT USE SPIRIT, LIGHTER-FLUID OR KEROSENE FOR LIGHTING.

6. IF THE BURNER DOES NOT LIGHT WITHIN 5 SECONDS, TURN BURNER CONTROL KNOB TO "OFF", WAIT 5 MINUTES, AND REPEAT LIGHTING INSTRUCTION. AFTER LIGHTING, OBSERVE THE BURNER FLAME. MAKE SURE ALL BURNER PORTS ARE LIT AND FLAME HEIGHT MATCHES ILLUSTRATION SHOWN ABOVE.

WARNING: NEVER LEAN OVER THE COOKING AREA WHILE LIGHTING YOUR CAMP STOVE. KEEP YOUR FACE AND BODY A SAFE DISTANCE (AT LEAST 18 INCHES / 457 MM) FROM THE COOKING SURFACE WHEN LIGHTING YOUR STOVE BY MATCH.

7. IF THE ABOVE POINTS DO NOT WORK, SEE MANUAL LIGHTING PROCEDURE.

MANUAL LIGHTING PROCEDURE

- 1. OPEN WIND SHIELD PANELS DURING LIGHTING.
- 2. SET ALL CONTROL KNOBS TO THE "OFF" POSITION.
- 3. OPEN THE CYLINDER/GAS VALVE ACCORDING TO THE OPERATING INSTRUCTIONS ON TANK.
- 4. QUICKLY AND CAREFULLY, USE A LONG MATCH OR LONG-NOSED LIGHTER TO LIGHT THE BURNER. POSITION LIT MATCH NEAR THE SIDE OF THE BURNER.

CAUTION: DO NOT ATTEMPT TO LIGHT ANOTHER AREA OF THE BURNER. THIS CAN CAUSE INJURY.

- 5. PUSH AND TURN THE BURNER CONTROL KNOB COUNTER-CLOCKWISE TO HIGH, HOLD THIS KNOB IN FOR 10 SECONDS AFTER THE BURNER IS LIT. YOU WILL HEAR THE "SNAPPING" SOUND OF THE SPARK UNTIL AFTER THE KNOB IS RELEASED.
- 6. REPEAT SAME STEPS FOR OTHER BURNERS, AS EACH BURNER LIGHTS INDEPENDENTLY.

NOTE: DO NOT USE SPIRIT, LIGHTER-FLUID OR KEROSENE FOR LIGHTING.

7. IF THE BURNER DOES NOT LIGHT WITHIN 5 SECONDS, TURN BURNER CONTROL KNOB TO "O", WAIT 5 MINUTES, AND REPEAT LIGHTING INSTRUCTION. AFTER LIGHTING, OBSERVE THE BURNER FLAME. MAKE SURE ALL BURNER PORTS ARE LIT AND FLAME HEIGHT MATCHES ILLUSTRATION SHOWN PREVIOUSLY.

WARNING: NEVER LEAN OVER THE COOKING AREA WHILE LIGHTING YOUR CAMP STOVE. KEEP YOUR FACE AND BODY A SAFE DISTANCE (AT LEAST 18 INCHES / 457 MM) FROM THE COOKING SURFACE WHEN LIGHTING YOUR STOVE BY MATCH.

8. IF THE BURNER GOES OUT DURING OPERATION, TURN THE CONTROL KNOBS TO THE "OFF" POSITION. WAIT FIVE MINUTES BEFORE ATTEMPTING TO RELIGHT TO ALLOW ANY ACCUMULATED GAS TO DISSIPATE. IF THE BURNER DOES NOT LIGHT OR IF THE ABOVE POINTS DO NOT WORK, SEE TROUBLESHOOTING.

SHUTTING OFF YOUR UNIT

- 1. WHEN FINISHED COOKING, TURN GAS CYLINDER VALVE TO THE CLOSED POSITION, AND ALLOW THE REGULATOR KNOB TO POP OUT. THIS SAFETY FEATURE LOCKS THE REGULATOR KNOB TO ENSURE THAT THE GAS IS NO LONGER FLOWING.
- 2. TURN CONTROL KNOBS TO THE "OFF" POSITION.

NOTE: A "POOF" SOUND IS NORMAL AS THE LAST OF THE LP GAS IS BURNED.

3. DISCONNECT GAS SUPPLY BY FOLLOWING THE DISCONNECT A GAS CYLINDER INSTRUCTIONS.

WARNING: ALLOW THE STOVE TO COOL COMPLETELY, AND REMOVE THE GAS CYLINDER, BEFORE MOVING, TRAVEL, OR FOR STORAGE.

COLLAPSING FOR TRANSPORT

YOUR STOVE CAN QUICKLY AND EASILY BE COLLAPSED FOR STORAGE AND EASY TRANSPORTATION. TO FOLD AND SECURELY TRANSPORT YOUR STOVE, SIMPLY FOLLOW THE BELOW INSTRUCTIONS.

IMPORTANT: ALWAYS ENSURE THE STOVE IS COMPLETELY COOLED, DISCONNECTED FROM A GAS SUPPLY, AND THAT ALL ACCESSORIES ARE REMOVED FROM THE STOVETOP AND SIDE TABLE SURFACES.

- 1. FOLD IN THE WIND SHIELD SIDE WINGS, THEN FOLD DOWN ALL WIND SHIELD PANELS SO THEY ARE FLAT ON THE STOVETOP.
- 2. HOLDING THE SIDE TABLE WITH ONE HAND, UNHOOK THE LOCKING PLATE FROM THE LOCKIN PIN ON THE SUPPORT FRAME. SWING THE SUPPORT FRAME OUTWARD, THEN LAY FLAT ONTO THE SIDE TABLE.
- 3. FLIP THE SIDE TABLE/SUPPORT FRAME OVER AND ONTO THE STOVE TOP, AND FASTEN THE BRACKET WITH THE DRAW LATCH. THE BRACKET IS SECURE ONCE THE SAFETY CATCH OF THE DRAW LATCH IS LOCKED. THE SAFETY CATCH PREVENTS THE DRAW LATCH FROM OPENING.
- 4. FOLD IN THE FRONT COVER.

NOTE: THE FRONT COVER WILL ONLY CLOSE IF THE BURNER CONTROL KNOBS ARE IN THE "OFF" POSITION.

- 5. CAREFULLY, TIP AND PLACE THE CAMP STOVE ON ITS SIDE (HORIZONTAL) TO FOLD IN THE SUPPORT LEGS. PUSH DOWN ON THE LOCKING PIN TO RELEASE EACH SUPPORT LEG. FOLD IN EACH OF THE FOUR SUPPORT LEGS UNTIL THE LOCKING PINS LOCK.
- 6. MOVE THE CAMP STOVE TO DESIRED LOCATION, OR TO VEHICLE FOR TRANSPORT, IMMEDIATELY TO AVOID INJURY TO YOURSELF OR DAMAGE TO THE UNIT.

IMPORTANT: TAKE SPECIAL CARE OF THE REGULATOR AND HOSING AS YOU COLLAPSE AND TRANSPORT THIS UNIT.

CARE AND MAINTENANCE


CHECKING THE GAS LEVEL

 TO CHECK THE AMOUNT OF FUEL IN A GAS CYLINDER, THE CAMP STOVE MUST BE IN OPERATION. PLACE YOUR HAND AT THE TOP OF THE GAS CYLINDER AND SLOWLY MOVE DOWN THE SIDE UNTIL THE GAS CYLINDER FEELS COOL TO THE TOUCH. THIS WILL INDICATE THE APPROXIMATE AMOUNT OF GAS IN YOUR GAS CYLINDER; IF ¾ EMPTY, REPLACE WITH A FULL GAS CYLINDER.

IMPORTANT: DO NOT USE CHARCOAL BRIQUETTES OR ANY FLAMMABLE MATERIAL WITH YOUR CAMP STOVE. USE OF SUCH MATERIAL WILL VOID YOUR WARRANTY AND MAY LEAD TO A FIRE, EXPLOSION AND BODILY HARM.

BURNER COMPONENTS

- CLEAN THE BURNER WHENEVER HEAVY BUILD-UP IS FOUND, TO ENSURE THAT THERE ARE NO SIGNS OF BLOCKAGE (DEBRIS, INSECTS) ON THE BURNER TUBE OR IN THE BURNER PORTHOLES. AFTER PERIODS OF STORAGE, SPIDERS OR SMALL INSECTS CAN BUILD NESTS, WEBS, AND LAY EGGS IN THE BURNER TUBE, OBSTRUCTING THE FLOW OF GAS TO THE BURNER. A CLOGGED TUBE CAN LEAD TO A FIRE BENEATH THE APPLIANCE. IF STORING THE CAMP STOVE, OR BEFORE AN EXTENDED PERIOD OF NON-USE, REMOVE THE BURNER AND WRAP WITH ALUMINUM FOIL TO REDUCE THE RISK OF INSECTS ENTERING THE BURNER HOLES.
- THE BURNER HAS BEEN PRESET FOR OPTIMAL FLAME PERFORMANCE. A BLUE FLAME, POSSIBLY WITH A SMALL YELLOW TIP, IS THE RESULT OF THE OPTIMAL AIR AND GAS MIXTURE. IF FLAMES ARE EXCESSIVELY YELLOW, ORANGE OR IRREGULAR, CLEAN THE OIL AND FOOD DEPOSITS ON THE BURNER SURFACE AND THE BURNER PORTHOLES TO INCREASE AIRFLOW.
- IF THE BURNER IS REMOVED DURING CLEANING OR MAINTENANCE, ENSURE THAT BURNER IS REPLACED IN THE PROPER POSITION WITH THE BURNER PORTHOLES FACING UPWARD. NOTE ILLUSTRATION SHOWN. WRONG PLACEMENT WILL LEAD TO FIRE, EXPLOSION AND BODILY HARM.
