


(1) Fairy Curtain Lights (8 ft.)



(1) Remote Control




(1) AC Power Adapter

ATTACHING AC POWER ADAPTER

Connect the Two Pronged Plug from the Curtain Lights to the provided AC Power Adapter.



Use the provided Fastener to secure the curtain light plug to the Power Adapter.




LIGHT CONTROL BOX INSTRUCTIONS

- 1 Click the button on the light control box to turn device ON.
 - The unit will automatically enter the first function of the 8 modes.

1. Combo 2. Twinkle 3. Order 4. Glow 5. Chase 6. Fade 7. Flash 8. Solid

2 Continue to click the Control button to cycle through each of the 8 modes.




REMOTE CONTROL INSTRUCTIONS

- 1 On/Off buttons turn the lights on and off.
- Press the TIMER button to set the unit to automatically stay 6 hours ON and 18 hours OFF.

This timer will repeat every 24 hours.

- Press the TIMER OFF button to turn OFF TIMER.
- Press on the preferred mode to choose your light effect.
- Dim the light up and down using the (+) and (-) buttons.
