LUMIX GH6 Launch Promotion (hereafter referred to as the "Promotion") is promoted by Panasonic Consumer Electronics Company, Division of Panasonic Corporation of North America, whose registered address is Two Riverfront Plaza, Newark, New Jersey 07102 (the "Promoter").

Participant's participation in the Promotion constitutes Participant's full and unconditional agreement to and acceptance of these Terms and Conditions and the decisions of Promoter, which are final and binding.

PROMOTION PERIOD

Promotion Period: February 21, 2022, 9:00 AM EST– June 18, 2022, 11:59 PM EST

Claim Period: February 21, 2022, 9:00 AM EST– July 16, 2022, 11:59 PM EST .

Free gift will be provided to Participants in the order in which Qualifying Products are purchased from a participating retailer and while supplies last.

Note: Promoter's computer is the official timekeeping device for this Promotion.

ELIGIBILITY

The Promotion is open only to legal permanent residents of: the fifty (50) United States, the District of Columbia, Puerto Rico, and Guam (excluding, without limitation, all other U.S. territories and possessions, and where prohibited by law), who are 18 years of age or older. This Promotion is subject to all federal, state, and local laws and regulations and is void outside the U.S. and where prohibited by law. Promoter is the sole judge of eligibility and may determine that a Participant is ineligible to participate in the Promotion for a variety of reasons not described here but in its sole discretion.

HOW TO PARTICIPATE

Step 1: Purchase a **LUMIX GH6 (DC-GH6BODY or DC-GH6LK)** ("Qualifying Product") during the Promotion Period (February 21, 2022 – June 18, 2022) from a participating retailer in the US. A list of participating retailers can be found at <https://shop.panasonic.com/view-all-camera-authorized-retailers.html>. All Qualifying Products must be new and genuine Panasonic products. Qualifying Products purchased after the Promotion Period will be deemed invalid and ineligible to participate in the Promotion. Any Qualifying Products that were returned for a refund by Participant are not eligible for this Promotion. Participants expressly agree they are responsible to send back at their cost any delivered Gifts that were claimed based on a returned Qualifying Product.

Step 2: File a claim at www.lumixgh6.com once the Qualifying Product has been received. All claims must be made during the Claim Period (February 21, 2022 – July 16, 2022). To file a claim, Participants will be required to submit a copy of the full purchase receipt or deposit receipt showing the participating dealer, date and time of purchase, model number, purchase price and confirmed payment, as well as the product serial number found on the base of the product or the side of the product box, and a photograph of the serial number and barcode. Purchase receipt must include the product name (model number) purchased, price paid, retailer name and the date and time of purchase or the claim will be considered incomplete. Claims without a valid serial number and photograph will not be accepted. Claims made by fax, telephone, email or post will not be accepted. Claims filed after the Claims Period or any incomplete, invalid, falsified, or fraudulent claims will not be eligible for the Promotion.

Participants will receive a confirmation email following claim receipt.

Free Gift While Supplies Last
