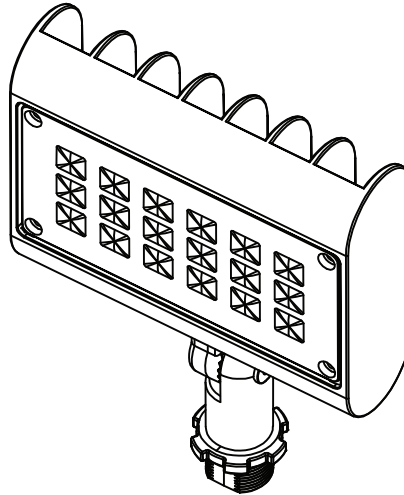


SINGLE HEAD COMMERCIAL SECURITY FLOOD LIGHT INSTALLATION INSTRUCTIONS

WARNING: These products may represent a possible shock or fire hazard if improperly installed or attached in any way. Products should be installed in accordance with the owners manual, current electrical codes and/or the current National Electric Code (NEC).

PARTS INCLUDED

- (1) Single head commercial security flood light
- (1) Nut
- (3) Wire nuts
- (1) Dusk to dawn sensor cap



CAUTION, IMPORTANT SAFETY INSTRUCTIONS - Make sure the supply voltage is the same as the rated luminaire voltage. Do not install where marked operating temperatures exceed the ignition temperature of the hazardous atmosphere. Do not operate in ambient temperatures above those indicated on the luminaire nameplate. To avoid the risk of fire, explosion, or electric shock, this product should be installed, inspected and maintained by a qualified electrician only, in accordance with all applicable electrical codes. Be certain electrical power is OFF before and during installation and maintenance.

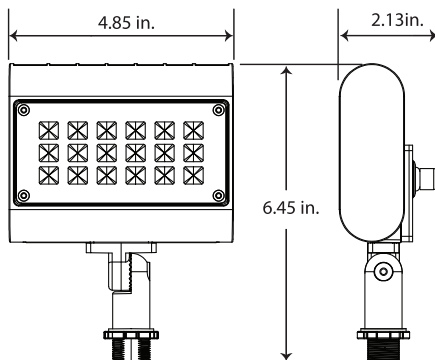
For supply connections use wire rated for at least 90°C

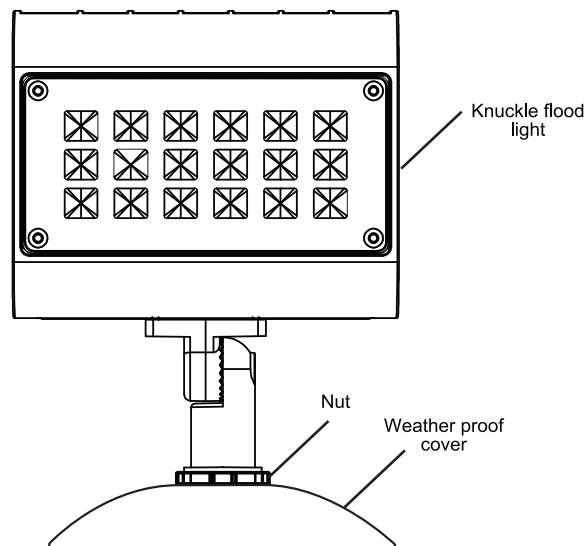

J-Box Mount Installation

1. Check the weatherproof cover hole size before starting any installation. The knuckle flood light has a 1/2" screw thread.
2. Install the knuckle flood light into the weather proof cover (not included). Tighten the nut on the knuckle flood light to secure it from moving (Fig A).

3. Connect the J-box power supply wires to the knuckle flood wires: hot to black, neutral to white and ground to green (Fig B).
4. Mount the weather proof cover onto the J-Box (Fig C).

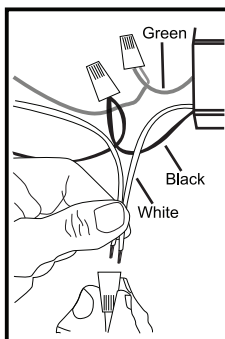
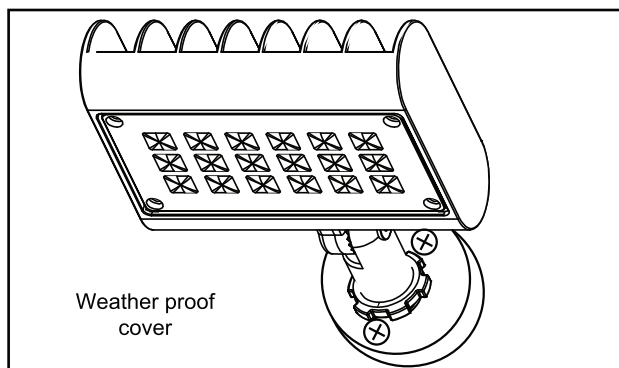

5. To adjust knuckle flood light aiming angle, un-tighten the adjustable screw of knuckle. Do not completely disengage. Hold the knuckle flood light at selected angle and tighten the screw firmly.
6. Turn ON power and check for proper operation.
