




## **Getting Started:**

#### **Connect the Neon Flex**

Connect the neon flex light to the power supply then connect the plug as shown in the image below.




Note: When using outdoors, plug the unit into an appropriately rated GFCI receptacle with cover.



#### **Prepare the Neon Flex**

- Measure the desired length before installation.
- Clean the mounting area thoroughly (surface must be free of dust, dirt or grease).
- Avoid bending the strip light which may damage the LEDs.






#### **Mount the Neon Flex**

Unroll the neon flex and place near mounting location. Ensure cord can reach your power source. Do not connect to power yet.

- Mark your desired mounting location.
- Align the mounting clips (DD) and fasten using the mounting screws (EE).
