It may also support the occasional relief of stress-induced fatigue and help maintain cardiovascular and neurological health.\*<sup>2–5</sup> The antioxidant CoQ10 is a component of the mitochondrial respiratory chain and an essential cofactor in the electron transport system. CoQ10 may also help maintain cardiovascular and neurological health.\*<sup>6</sup>

ElevATP® is a blend of plant bio-inorganic trace minerals and an apple extract rich in polyphenols such as procyanidins and chlorogenic acid. It may help support ATP levels.<sup>7,8</sup> It may also support healthy muscle conditioning.<sup>\*9–11</sup> Given that mitochondria are the primary source of free radical production within a cell, the bioavailable Opitac L-glutathione and superoxide dismutase (from Extramel®) provide antioxidant activity, which is vital for cellular health.<sup>\*</sup> Antioxidant activity is critical to redox balance within a cell and may also support the occasional relief of stress-induced fatigue.<sup>\*12–14</sup>
