The purchase of this pool extends a specific warranty, based on model purchased, as outlined in the following warranty schedule. The warranty covers the frame components and wall manufactured by ASAHI only. When making a claim under this limited warranty, the customer must have previously registered with ASAHI by completing the warranty card and mailing it to Asahi at time of purchase, the customer must be able to produce his original bill of sale, showing clearly the date of sale, the name of dealer from whom pool was purchased, the model of the pool, and the price paid.

This warranty is subject to the following terms and conditions.

1. ASAHI CHEMICAL INDUSTRY CO., LTD. is the warrantor of this product, the claims mailing address is:

2. This warranty is extended to the original purchaser (consumer) only and is non-transferable..
3. Under no circumstances does it cover any accessory not manufactured by ASAHI, such as but not limited to the filter, pump, ladder, slimmer, or liner. These items may carry warranties from their respective manufacturers.
4. This ASAHI warranty prorates the frame component and wall costs over a specific period as determined by the model purchased. If any defect in workmanship or material is confirmed by ASAHI during "full coverage" period of the warranty, the part(s) will be repaired or replaced (but not installed) free of charge. If determination of defect cannot be made by the local dealer. The purchaser must (after authorization from ASAHI) ship the part(s) to ASAHI. Failure of the purchaser to allow the dealer and / or manufacturer to inspect the product claimed to be defective, shall render this warranty null and void.
5. Freight charges for part(s) returned to ASAHI for replacement or repair must be shipped prepaid. Freight charges for the repaired, or replaced, parts to the consumer will also be paid by the consumer. Freight charges will be paid by ASAHI in the first year of purchase, after a determination of defect has been made
6. Any part(s) replaced or repaired must be removed, installed, or reinstalled at the consumer's expense. Under no condition will ASAHI be responsible for any labor charges incurred in connection with this warranty.
7. No incidental, consequential, or other damages will be paid. Under no circumstances will ASAHI be responsible for cost of loss of water, chemicals, or other damage resulting there from in connection with this warranty.
8. Asahi is not responsible for damage due to faulty or improper installation. This warranty is null and void if the design of this product is altered, any part is substituted for an original part, or if the pool is not installed, and maintained according to the factory supplied instructions. This pool is to be installed on level ground, as a portable above ground residential swimming pool. Burying any components of the pool below the ground voids all warranties.
9. Regular maintenance and periodic inspections should be performed. The following conditions must be corrected immediately or severe damage may result.
  - a. The pool cannot be left standing without water.
  - b. Holes, rips, or any damage to liner, must be repaired or replaced promptly.
  - c. Skimmer gaskets and return gaskets must be periodically inspected and replaced at the first signs of leakage.
  - d. Metal surfaces that have been scratched or nicked and bare metal is exposed should be touched up as soon as possible.

- e. A stable water level must be maintained over the winter months, ice and snow on top of a winter cover tightly attached to the pool without the support of water, will cause damage to the pool.

Any of these conditions not immediately corrected is considered neglect and renders this warranty null and void.

10. ASAHI shall not be responsible for any damage that results from; your acts, the acts of others, improper chemical balance, poor drainage (run off) around pool area, improper winterization, any saltwater use without MIRAGE&AFFINITY All resin or Salt friendly 8R hybrid resin pool, or abnormal environmental conditions.
11. To obtain performance under this warranty, the purchaser should first contact the dealer from whom the product was purchased. In the event that the consumer and dealer cannot reach satisfactory agreement, the consumer should contact Asahi at the address shown above. At that point ASAHI will work with the consumer, dealer, or distributor to ascertain the facts and make a determination as to the factory's position on resolution.
12. Warranty is made to the original purchaser "consumer" only and is non transferable.
13. This warranty gives the consumer specific legal rights. There are no warranties expressed or implied by ASAHI except those stated herein. The intent of this warranty is to correct a factory or material defect as expeditiously as possible. Most dealers attempt to maintain a parts inventory from which to make corrective action when necessary. In the event the dealer does not have stock, an authorized distribution center will ship the parts via appropriate means. Every effort will be made to ship on a timely basis after receiving the order. ASAHI may discontinue models, colors, or designs, but will attempt to maintain or locate exact or compatible replacement parts when possible.
