Scotch® Box Sealing Tape 311+ has been applied to fiberboard boxes with good results at freezer and refrigeration temperatures of 20°F (-6.6°C to 10°C). Once applied, Scotch® Tape 311+ performs well on fiberboard boxes subjected to temperatures below 32°F (0°C).

Storage and Shelf Life

Store in a clean, dry place. Temperature of 40-80°F (4-26°C) and 40 to 50% relative humidity are recommended. To obtain best performance, use this product within 18 months from date of manufacture.
