General Use Directions:

Note:

Test the spray cleaner in an inconspicuous area to make sure the carpet is colorfast. Apply ready-to-use solution to a small area. After several minutes, blot the carpet with a clean white cloth or paper towel. If color from the carpet transfers to the cloth or towel, discontinue use.

- Mix 1 part concentrate with 20 parts warm water (6 ounces per gallon).
- Vacuum the carpet area thoroughly.
- Use a 3MTM All Purpose Sprayer (Model AP-1) or a bulk pressurized sprayer to apply the spray cleaner.
- 4. Apply the ready-to-use solution at a rate of 200-300 ft² per gallon.
- Allow 1-2 minutes dwell time for the cleaner to penetrate the fiber.
- Clean using a 175 rpm floor machine with a 3M Carpet Bonnet Pad or carpet brush.
- Do not over-wet the carpet bonnet pad by soaking it, however spray the pad with spray cleaner before starting to reduce the drag of the machine on the carpet.
- Bonnet the area until the light foam generated is worked into the carpet.
- When the pad becomes heavily soiled, turn the pad over and continue.
- 10. Change to a clean pad when necessary.
- 11. Vacuum the area when the carpet is completely dry.
