

TOOLS REQUIRED

- 1. 14 mm open end or adjustable wrench
- 2. #2 phillips screwdriver

ASSEMBLY INSTRUCTIONS

- 1. Place the Seat Bracket (2) on the underside of the Padded Seat (1). Align the holes in the Seat Bracket with the 4 holes in the center of the Padded Seat and hand tighten with the 4 machine screws (3). Use a #2 phillips screwdriver for final tightening.
- 2. Hand thread the 5 Casters (6) onto Base Frame (7). Tighten with a 14 mm open end or adjustable wrench.
- 3. Place the Base Cover (5) over the center of the Base Frame (7).
- 4. Insert the Pneumatic Cylinder (4) into the center opening in the Base Frame (7), then place the Seat assembly from step 1 onto the thinner end of the Pneumatic Cylinder. Press down to ensure a tight and secure fit.

OPERATION

TO RAISE SEAT:

Stand next to stool. Lift handle, and release when seat is at the desired height.

TO LOWER SEAT:

Sit on the stool. Lift handle, and release when the seat is at the desired height.
