

## LIMITED WARRANTY

### APCRBC154-CP

#### **CYBERPOWER WARRANTY:**

Read the following terms and conditions carefully before using the CyberPower APCRBC154-CP (the Product). By using the Product you consent to be bound by and become a party to the terms and conditions of this Limited Warranty (referred to as "Warranty"). If you do not agree to the terms and conditions of this Warranty, you should return the Product for a full refund prior to using it.

**CAUTION!** This Product is not recommended for use by children. Keep out of reach of children.

**CAUTION!** Always keep Product away from flammable objects and materials, conductive contaminants, heating elements, and exposure to direct sunlight.

**WARNING!** Risk of serious injury or death — never install the Product during a lightning storm.

**WARNING!** To reduce the risk of fire or electric shock, use only in dry locations and only indoors. Do not allow water or other liquids to come in contact with the Product and never immerse the Product in water.

#### **WHO IS PROVIDING THIS WARRANTY?**

Cyber Power Systems (USA), Inc. ("CyberPower") provides this Limited Warranty. Except as required by law, this Warranty only covers the original purchaser ("Initial Customer"). The Warranty may not be transferred to any third party and coverage ends if the Initial Customer sells or otherwise transfers the Product. To be covered, the Initial Customer must still be the owner of the Product at the time of the failure that results in the claim made under this Warranty ("Occurrence").

#### **WHAT DOES THIS WARRANTY COVER?**

This Warranty is a Limited Warranty, subject to the limitations and exclusions set forth herein. This Warranty covers defects in design, materials and workmanship in the Product under normal use and conditions and when installed and used in accordance with this manual. It does not cover equipment connected to the Product at the time of the Occurrence ("Connected Equipment") that was damaged due to the failure of the Product. All implied warranties are disclaimed to fullest extent allowed by law, and in any event, including any implied warranties of merchantability, fitness for a specific purpose, and quality are limited to the duration of the Warranty granted hereunder.

This Warranty only applies to consumers and shall not apply in any commercial contexts absent express contractual arrangements between CyberPower and the purchaser.

#### **WHAT IS THE PERIOD OF COVERAGE?**

This warranty covers the Product for two years from the date of purchase, whereby the Product will be free from defects in design, material and workmanship subject to the terms of this Warranty. Any implied Warranty claims shall be limited to two years from the date of purchase.

#### **WHO IS COVERED?**

This warranty only covers the Original Purchaser. Coverage ends if you sell or otherwise transfer the Product.

#### **HOW LONG DO YOU HAVE TO MAKE A CLAIM?**

All claims must be made within ten (10) days of the occurrence.

#### **HOW TO MAKE A WARRANTY CLAIM**

1. Before contacting CyberPower, please gather the following information:
  - a. The date of the Occurrence.
  - b. Model number and serial number (if applicable) of the Product.
  - c. Copy of the original receipt for the Product, including where you purchased the Product and the date of the purchase.
  - d. A brief statement of the Occurrence and description of the issue.
  - e. A description of the Connected Equipment at the time of the Occurrence (e.g., computer tower, computer monitor, printer, modem, etc.).
2. Contact CyberPower within 10 days of the Occurrence toll-free at 1-877-297-6937 (press 1 for Technical Support); visit our website at [www.CyberPowerSystems.com/Support](http://www.CyberPowerSystems.com/Support); or write to us at Cyber Power Systems (USA), Inc., 4241 12th Ave. E., STE 400, Shakopee, MN 55379.
3. A CyberPower representative will contact you confirming receipt. Upon review of your claim, you will be provided with claim forms and instructions how to proceed.
4. You must prepay all shipping costs, and you are responsible for packing and shipping the Product to CyberPower for evaluation.

#### **WHAT WILL WE DO TO CORRECT PROBLEMS?**

CyberPower or its representative will inspect and examine the Product, and reserves the right to inspect the Product, any and all Connected Equipment, and the site of the Occurrence. The Product and all Connected Equipment must remain available for inspection until the claim is finalized. If it is determined by CyberPower or its representative, in its sole discretion, that a defect resulted in failure of the Product during its normal use, CyberPower's sole responsibility is to repair, replace, or refund the Product (at CyberPower's sole option).

#### **WHO PAYS FOR SHIPPING?**

We pay when we send items to you; you pay when you send items to us.

#### **WHAT ARE SOME EXAMPLES OF WHAT THIS WARRANTY DOES NOT COVER?**

This Warranty does not cover or apply to: Products which are not defective or broken; Products that are working as described in the user manual; to any abnormal wear, misuse, modification, operation or storage outside environmental limits of the Product or the equipment connected to it, nor for damage while in transit or in storage, nor if there has been improper operation or maintenance, or use with items not designed or intended for use with the Product, such as laser printers, appliances, aquariums, medical or life support devices, etc. All warranties are null and void if, in CyberPower's sole discretion CyberPower determines: the Product in use during the Occurrence is not provided to CyberPower or its representative for inspection upon CyberPower's or its representative's request at the sole expense of the Original Purchaser; that the Product or Connected Equipment have been improperly installed, altered in any way or tampered with; that the damage did not result from the Occurrence or that no Occurrence in fact took place; the repair or replacement of the Connected Equipment is covered under a manufacturer's warranty; or if CyberPower or its representative determines that the Product or the Connected Equipment were not used under normal operating conditions, or were not used in accordance with all labels or instructions provided with the Product.

CyberPower does not cover or undertake any liability in any event for any of the following:

1. Damage from any circumstance described as excluded above with respect to the Product.
2. Loss of or damage to data, records, or software or the restoration of data or records, or the re-installation of software.
3. Damage following any alteration, modification, or tampering with the Product.
4. Damage when the Product was not installed or used in accordance with the user manual or if the Product was used in conjunction with generator power.
5. Damage when the Product is used contrary to any instructions provided with the Product, or for any unintended or prohibited use.

#### **WHAT OTHER LIMITATIONS APPLY?**

To the extent permitted by law, this Warranty and the remedies set forth are your sole and exclusive remedy and are provided in lieu of all other warranties, remedies and conditions, whether oral, written, statutory, express or implied. CyberPower disclaims all statutory and implied warranties, including without limitation, warranties of merchantability, quality, and fitness for a particular purpose and warranties against hidden or latent defects, to the fullest extent permitted by law. In so far as such warranties cannot be disclaimed, CyberPower limits the duration and remedies of such warranties to the duration of this Limited Warranty if so required, and, at CyberPower's option, the repair or replacement services described herein. Some States do not allow limitations on how long an implied warranty (or condition) may last, so the limitation described above may not apply to you. CyberPower may require, as a condition of fulfilling duties under this warranty, including by way of example the replacement or refund of the Product, that Consumer demonstrate that the Product be provided to CyberPower and be free and clear of liens and other encumbrances.

1. This Warranty does not apply unless the Product was properly installed in the UPS that this Product was intended to be used in or if that UPS is not connected to properly wired and grounded outlets (including compliance with electrical and safety codes of the most current electrical code), without the use of any adapters or other connectors.
2. The UPS this Product is used in must not have been used in a manner that breached any terms of the warranty that originally came with the UPS, even if that warranty has since expired.
3. The Product and equipment connected to it must have been used properly in a suitable and proper environment and in conformance with any license, instruction manual, or warnings provided with the Product and the equipment connected to it.
4. This Warranty does not apply unless the Product and the UPS were connected to utility power via properly wired and grounded electrical outlets (including compliance with the most current electrical and safety codes), without the use of any adapter or other connector (a three-to two-prong adapter may not be used with the UPS). Any such installation voids the Warranty.
5. Damage from causes other than AC Power Line Transients, spikes, or surges on properly installed, grounded and code-compliant 120 volt power lines when properly installed and connected.
6. Damage from any circumstance described as excluded above with respect to the Product.
7. Damages from fire, flood, wind, rain, rising water, leakage, or breakage of plumbing, abuse, misuse, or alteration of either the UPS or the Product.
8. CyberPower excludes any liability for indirect, special, incidental or consequential damages, whether for any injury, damage to or loss of property, loss of profits, business interruption, or loss of information or data.
9. The Product is not for use in high-risk activities or with aquariums. The Product is not intended for use in hazardous environments requiring fail-safe performance, or for use in any circumstance in which the failure of the Product could lead directly to death, personal injury, or severe physical or property damage, or that would affect operation or safety of any medical or life support device used in direct patient care (collectively, "High Risk Activities"). CyberPower expressly disclaims any express or implied warranty of fitness for High Risk Activities or with aquariums. CyberPower does not authorize use of any of its products in any High-Risk Activities and CyberPower expressly disclaims any express or implied warranties for use in High-Risk Activities. ANY SUCH USE IS IMPROPER AND IS A MISUSE OF THE PRODUCT.
10. Warranty does not cover or apply to: Products which are not defective or broken or which are working as described in the user manual; misuse, modification, operation or storage outside environmental limits of the Product, nor for damage while in transit or in storage, nor if there has been improper installation, operation or maintenance, or for the use with items not designed or intended for use with the Product. All warranties are null and void if, in CyberPower's sole discretion: the Product in use during the Occurrence is not provided to CyberPower or its representative for inspection upon CyberPower's or its representative's request at the sole expense of the Initial Customer; CyberPower or its representative determines that the Product has been improperly installed, altered in any way or tampered with; CyberPower or its representative determines that the damage did not result from the Occurrence or that no Occurrence in fact took place; or if CyberPower or its representative determines that the Product or the Connected Equipment were not used under normal operating conditions or in accordance with all labels or instructions.
11. CyberPower may, as a condition of fulfilling duties under this warranty, including by way of example the replacement or refund of the Product, that Consumer demonstrate that the Product be provided to CyberPower and be free and clear of liens and other encumbrances. CyberPower reserves the right of subrogation under any existing insurance policies the Initial Customer may have. CyberPower's obligation is reduced by any amounts that the Initial Customer is entitled to recover from other sources regarding the Connected Equipment, including insurance, other warranty, or extended warranty coverage, whether or not the Initial Customer makes a claim for recovery.
12. TO THE FULLEST EXTENT PERMITTED BY LAW, CYBERPOWER SHALL HAVE NO LIABILITY FOR DIRECT, INDIRECT, SPECIAL, INCIDENTAL, PUNITIVE, MULTIPLE, OR CONSEQUENTIAL DAMAGES OF ANY KIND, WHETHER FOR DAMAGE TO OR LOSS OF PROPERTY, FOR INJURY OR DAMAGE TO BUSINESS, BUSINESS INTERRUPTION, LOSS OF INFORMATION OR DATA, OR LOSS OF PROFITS, REVENUES OR GOODWILL. CYBERPOWER SHALL HAVE NO LIABILITY FOR PERSONAL INJURY UNDER THIS WARRANTY. THESE EXCLUSIONS APPLY REGARDLESS OF CAUSE, WHETHER ARISING UNDER BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE OR FAULT), STRICT LIABILITY OR OTHERWISE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH. THE PREVAILING PARTY SHALL BE ENTITLED TO THEIR COSTS, DISBURSEMENTS AND REASONABLE ATTORNEY'S FEES AND FOR ANY CLAIM UNDER THE WARRANTY OR OTHERWISE ASSOCIATED WITH THE PRODUCT. Some States do not allow the exclusion or limitation of incidental or consequential damages, or forum selection clauses, so those limitations may not apply to you. This Warranty gives you specific legal rights and you may have other rights, which vary from State to State. Additionally, State law may adjust the terms of the Warranty or the State or Province may impose additional obligations, or additional "implied warranties." To the extent necessary to comply with those laws, the terms of this Warranty should be read to adjust to those requirements only to the extent necessary to comply with such local law. Where any term of this Warranty is prohibited by such laws, that term shall be null and void, but the remainder of the Limited Warranty shall remain in full force and effect.
13. Unless prohibited by law, all claims concerning the Product or regarding the Warranty shall be limited to the remedies and limitations set forth here, and otherwise governed by Minnesota law. Any action to enforce these terms shall be in the state and federal courts serving Shakopee, Minnesota, without reference to conflict of law principles, and the parties expressly consent to jurisdiction in that venue. The parties agree that the United Nations Convention on Contracts for the International Sale of Goods shall not apply. However, before bringing a claim for a breach of a warranty, a claimant shall pursue a Warranty Claim with CyberPower as set forth in this Warranty. Thereafter, the parties shall resolve their dispute by binding arbitration. Any controversy or claim arising out of or relating to this contract, or the breach thereof, shall be settled by arbitration administered by the American Arbitration Association in accordance with its Consumer Arbitration Rules and judgment on the award rendered by the arbitrator may be entered in any court having jurisdiction thereof. Claims shall be heard by a single arbitrator. The place of arbitration shall be Minneapolis, Minnesota, United States and shall be governed by the laws of the State of Minnesota. Hearings will take place pursuant to the standard procedures of the Consumer Arbitration Rules that contemplate in person hearings. The arbitrators will have no authority to award punitive or other damages not measured by the prevailing party's actual damages, except as may be required by statute. The arbitrator shall not award consequential damages in any arbitration initiated under this section. Any award in an arbitration initiated under this clause shall be limited to monetary damages and shall include no injunction or direction to any party other than the direction to pay a monetary amount. Each party shall bear its own costs and expenses and an equal share of the arbitrator's and administrative fees of arbitration. The award of the arbitrator shall be accompanied by a reasoned opinion. Except as may be required by law, neither a party nor an arbitrator may disclose the existence, content, or results of any arbitration hereunder without the prior written consent of both parties. The parties agree that failure or refusal of a party to pay its required share of the deposits for arbitrator compensation or administrative charges shall constitute a waiver by that party to present evidence or cross-examine witness. In such event, the other party shall be required to present evidence and legal argument as the arbitrator may require for the making of an award. Such waiver shall not allow for a default judgment against the non-paying party in the absence of evidence presented as provided for above.
14. This Warranty is valid in all 50 U.S. states, the District of Columbia, Puerto Rico, and Canada. All other countries or territories are expressly excluded. The Warranty is null and void if CyberPower or its representative determines, in its sole discretion, that the Product or Connected Equipment has been improperly installed, operated, applied or maintained, operated in a failure mode or not in compliance with any license, instructions, labels, or warnings provided with the Product or the Connected Equipment, or if the Product or Connected Equipment has been altered in any way or tampered with. The Product must have been used at all times within the limitations of the Product's ratings and specifications.
