Capitol PS399 can be used as a wet-set or pressure sensitive adhesive with an optional extended working time up to 12 hours. This dynamic adhesive can be ready for traffic (including heavy rolling loads) after just 48 hours.

For adhering LVT, LVP, VCT, Carpet Tile, rolled vinyl sheet flooring, specialty underlayment, recycled rubber and sports flooring.

SUBSTRATES

Concrete, primed Gypsum and lightweight concrete APA grade plywood and OSB underlayment. Properly prepared existing flooring (excludes self-stick): VCT (single layer) sheet vinyl (single layer non-cushioned, fully adhered). Properly prepared ceramic tile. Cement backerboard and fiber cement underlayment. Fully secured specialty underlayment, Terrazo and radiant heated floors not exceeding 85°.

LIMITATIONS

- For interior controlled environments only.
- Not intended for use as a moisture mitigation system, see flooring manufacturer for any RH limitations for their respected products. Do not install in areas with known hydrostatic moisture problems or pH imbalances (pH tolerance 6-12).
- Ensure adequate ventilation during flooring installation.

5. INSTRUCTION

PREPARATION

Ensure the environment and flooring materials are fully acclimated per manufacturer's specific requirements and industry standards (prior to installation) to the temperature and humidity level expected during normal use (between 18-35°C /65-95°F with a relative humidity \leq 65%). Maintain these conditions after the installation.

Subfloors must be structurally sound, dry, smooth, flat (\leq 3/16" within 10'), level and free of excess moisture/alkali (<10) and all substances (oil, wax, debris, paint, sealers, adhesive residue, etc.) that may inhibit the bond of the adhesive or the performance of the flooring or its installation. Follow ASTM F710 substrate preparation guidelines. All pre-installation substrate moisture and pH testing must be completed and documented prior to installation.

All substrate irregularities must be adequately repaired. Patching compounds must be suitable for the use application, cement-based, polymer-modified, and applied according to the manufacturer's instructions.

INSTALLATION

Apply the adhesive uniformly onto the substrate using the recommended trowel or roller. Observe the appropriate amount of open time per application method. See application requirements below:

When installing over a porous substrate: for a permanent bond place flooring into semi-wet adhesive allowing adhesive transfer to the back of the flooring. For a pressure sensitive bond allow the adhesive to completely dry and become tacky to the touch before placing the flooring. When installing over non-porous substrate: always allow the adhesive to completely dry and become tacky to the touch before placing flooring. Once adhesive field has reached appropriate tack - install the floor covering into the adhesive field per manufactures guidelines. Roll the floor covering with a weighted roller per manufacturer's guidelines. Restrict foot traffic and moving of heavy objects for 24 hours.

(Permanent / Wet-Set Method)

Open Time: approx. 20 minutes Working Time: up to 40 minutes

(Pressure Sensitive / Full-Tack Method)

Open Time: 60 minutes Working Time: 12 Hours

Setup time will vary with environmental conditions and porosity of substrate.

CURING: Up to 24-48 hours

CLEAN UP: For best results, remove fresh adhesive immediately and completely with – warm, soapy water on a clean cloth. *Dried Adhesive* – mineral spirits sparingly on clean, cotton cloth. Do not pour directly onto the flooring.
