5. INSTRUCTION

PREPARATION

Installation environment and flooring materials must be fully acclimated prior to install meeting with manufacturer's requirements and industry standards (controlled between 65°F -85°F with a relative humidity of no greater than 65%). Subfloors must be structurally sound, dry, smooth, at ($\leq 3/16$ " within 10'), level and free of excess moisture / alkali and all substances (oil, wax, debris, paint, sealers, adhesive residue, etc.) that may inhibit the bond of the adhesive or the performance of the flooring or its installation.

Follow ASTM F710 substrate preparation guidelines. Concrete moisture testing must be performed in accordance with ASTM F1869 \leq 3lbs. and/or ASTM F2170 \leq 75% RH / pH tolerance <9. All substrate irregularities must be adequately repaired. Patching compounds must be suitable for the use application, cement-based and polymer-modified, and applied according to the manufacturer's instructions.

INSTALLATION

Pour adhesive directly from the pail to the substrate as needed. Use appropriate trowel size to spread the adhesive. Adhesive ridges should be well defined, consistent and achieve full coverage of the substrate. Observe the Open Time. Do not allow the adhesive to skin over. If the adhesive skins over, scrape away and re-apply.

Place flooring into the adhesive field per manufacturer's specific guidelines. Press the board firmly into the adhesive so that the underside is sufficiently wetted. Lift a board periodically to ensure 100% transfer of adhesive has occurred to promote a void free bond. Once the flooring is installed, use a weighted roller in both directions to secure the flooring or per manufacture's specific guidelines. Restrict foot traffic and moving of heavy objects for 24 hours after installation.

Open Time: approx. 20 minutes Working Time: up to 30 minutes

Setup time will vary with environmental conditions and porosity of substrate.

CURING: 24 hours

CLEAN UP: For best results, remove fresh adhesive immediately and completely with - warm, soapy water on a clean cloth. Dried Adhesive - mineral spirits sparingly on clean, cotton cloth. Do not pour directly onto the flooring
