Static weight anchor based on a segmented ring assembly of 25kg galvanised iron weights such that four weights form a 100kg ring of 1m diameter and successive rings, secured by cross straps, can be overlaid to give multiples of 100kg. The lower most weights are rubber coated and a Constant Force Post assembly with stainless steel D ring is bolted to the centre to create 300kg, 400kg and 500kg total weight assemblies.
