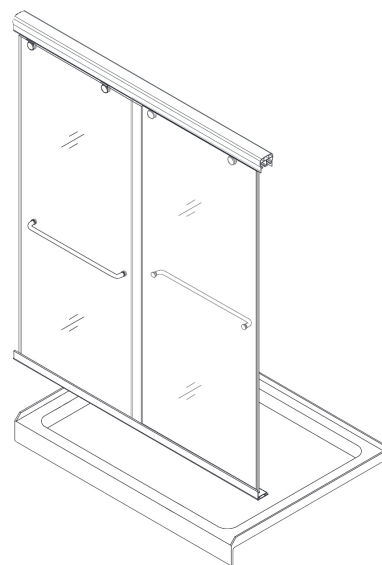

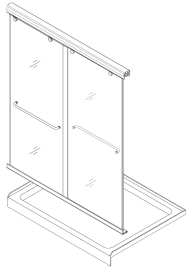

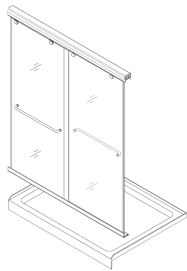

Upper and lower guiderails can be trimmed up to 4 in. for width adjustment.

ATTENTION! This model has NO adjustment for out-of-plumb (uneven) walls.

Drain opening fits any standard 2 in. compression fitted drain (drain not included).

Professional installation recommended; Drilling into the threshold is required for installation of this product.
