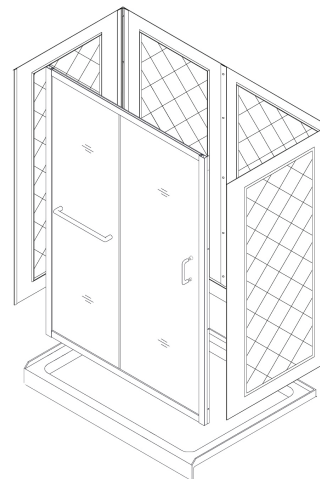

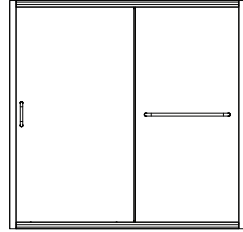
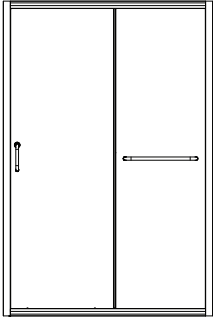

Up to 1 in. adjustment per side for out-of-plumb (uneven) walls.

Guide rails can be trimmed up to 4 in. for width adjustment.

Professional installation recommended.
