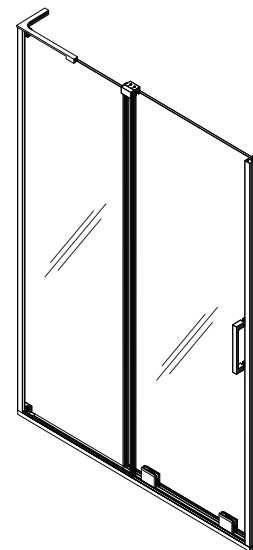

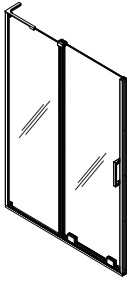

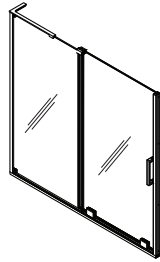

Model can be trimmed up to 4 in. for width adjustment; Up to 3/8 in. out-of-plumb (uneven walls) adjustment on each side.
