

INSTRUCTION MANUAL

SAFETY

Please retain these instructions for future reference.

This vehicle must be assembled by an adult who has read and understood the instructions in this manual. Keep the packaging and bags away from children and dispose of all packaging before use. Always use common sense and safe practices when operating this vehicle. This product contains or emits chemicals known in the state of California to cause cancer or birth defects or other reproductive harm.

NOTE: For best performance, only use this vehicle on flat and hard surfaces.

The following safety hazards may result in serious injury or death:

- This product contains small parts. Keep children away during assembly. Make sure to remove all packaging material and parts from underneath the vehicle body.
- Never open the battery. Batteries contain lead and lead compounds (acids) that are toxic and corrosive, and known to the state of California to cause cancer and reproductive harm.
- Limbs, hair, and clothing can get caught in moving parts. Always wear shoes, keep limbs away from moving parts, and do not wear loose clothing while operating this vehicle.
- This vehicle does not have brakes or braking capability. Do not leave a child unattended during operation. Do not use this in a location that may require braking capability, as this could result in loss of control, which may cause serious injury or death.
- Use of this vehicle near streets, motor vehicles, steps, bodies of water, sloped surfaces, hills, wet areas, flammable vapors, in alleys, at night, or in the dark could result in an unexpected accident.
- Use of this vehicle in unsafe conditions such as snow, rain, loose dirt, mud, sand, or gravel may result in an unexpected accident such as tipping over, and could damage the electrical system or battery.
- Do not operate this vehicle in an unsafe manner. Examples include but are not limited to:
 - Pulling the vehicle with another vehicle or similar device
 - Allowing more than one rider
 - Pushing the user
 - Traveling at an unsafe speed

BATTERY WARNINGS

The following safety hazards may result in serious injury or death:

- Use of a battery or charger other than the supplied rechargeable battery and charger may cause a fire or explosion. Only use the supplied battery and charger.
- Use of the rechargeable battery and charger for any other product may result in overheating, fire, or explosion. Never use the supplied rechargeable battery and charger with another product.
- Explosive gases are created during charging. Charge the battery in a well-ventilated area. Do not charge the battery near heat or flammable materials.



PRODUCT ASSEMBLY

1

Flip the vehicle over and lay it on a level surface. Remove the nut and washer from a front wheel axle. Slide on a part A wheel and replace the nut and washer to secure the wheel.

Repeat on the other side. Snap a part B wheel cover onto each wheel.





Remove the nut and washer from the rear wheel axle. Slide on a part A wheel and replace the nut and washer to secure the wheel.

Repeat on the other side. Snap a part B wheel cover onto each wheel.



Use the provided spanners to tighten the nuts.




PRODUCT ASSEMBLY

Flip the vehicle onto the wheels.

Join the connector from the part C steering wheel to the connector from the steering wheel mount.


Remove the bolt from the steering wheel, slide on the steering wheel, and then replace the bolt to secure the steering wheel to the mount.




Snap on the part E back frame.





Within the seat, insert the red wire into the red terminal on the battery.



Install the part G seat and secure it with two part 1 screws.




DASHBOARD DIAGRAM

Push down on the pedal to drive forward/reverse. Release the pedal to slow down and stop.



REMOTE CONTROL DIAGRAM

- Insert 2 AAA batteries into the remote control.




Linking the remote control:

1. Press and hold the frequency key for 2 to 4 seconds. The low speed LED lights will flash.
2. Turn the vehicle on. The low speed LED lights will stop flashing and remain on to indicate a successful link.
3. If the low speed LED lights continue to flash (indicating an unsuccessful link), remove and reinsert the batteries on the remote and repeat steps 1 and 2.

CHARGING INSTRUCTIONS AND WARNINGS

- Charging socket is located under the seat. Insert one end of the part I charger into the charging socket and plug the other end into a wall outlet.
- Charge the battery at least 18 hours before initial use.
- On average, you will need to charge the battery between 8 and 12 hours. Do not charge the battery for more than 20 hours. Failure to charge the battery as directed could cause permanent damage to the battery and void the warranty.
- Damage to the battery may occur if it is allowed to drain completely. Do not allow the battery to drain completely.
- Check the battery and charger (supply cord, connector) for wear and damage before charging. Do not charge the battery if damage has occurred.
- Only an adult who has read and understood the safety warnings should handle, charge and recharge the battery.



CARING FOR YOUR RIDE-ON

- Park the vehicle indoors or cover it with a tarp to protect it from wet weather.
- Do not leave the vehicle in the sun for long periods of time or fading may occur. Store in shade or cover with tarp.
- Do not wash the vehicle with a hose.
- Do not wash the vehicle with soap.
- Charge battery at least once a month to prolong the life of the battery.

Vehicle does not move	Low battery	Fully charge the battery
	Electrical protection	Stop use for several minutes and restart
	Switch not in the correct position	Completely press in switches
	Battery connectors disconnected	Plug in battery connectors
Battery does not recharge	Battery connectors disconnected	Plug in battery connectors
	Charger not connected to socket or outlet	Completely plug in the charger
Battery does not last	Battery does not have a full charge	Fully charge the battery
Battery is warm and makes a slight noise while charging	Normal	Normal
Slow speed	Low battery	Fully charge the battery
	Overloaded vehicle	Reduce the weight on the vehicle
	Uneven or sloped road	Drive on flat pavement
Vehicles shakes while driving	Loose connection to motor	Ensure the motor is properly connected to the battery
Vehicle is silent	Steering wheel is not properly connected	Properly connect the steering wheel connector
