CONTENTS

TOOLS REQUIRED

- 5/16" Wrench
- #2 Phillips Head Driver

NOTES

- If installing into a WMRK series rack, Stop Brackets are not required. Skip to step 5.
- If installing into a VRK series rack, knockout panels are not present. Omit steps 1 and 3.

STOP BRACKET INSTALLATION, TOP

- 1) Remove the bottom screws on the enclosure's top knockout panel using a 5/16" wrench.
- 2) Install Stop Bracket as shown using two of the provided #2 Phillips Head Screws.



STOP BRACKET INSTALLATION, BOTTOM

3) Remove the top screws on the enclosure's bottom knockout panel using a 5/16" wrench.

4) Install Stop Bracket as shown using two of the provided #2 Phillips Head Screws.

INSTALLATION CONTINUED NOTE: Door with latch opens first.

5) Install doors by depressing hinge pin and placing doors in hinge pin holes on enclosure.
