PRODUCT ASSEMBLY - TABLE

1

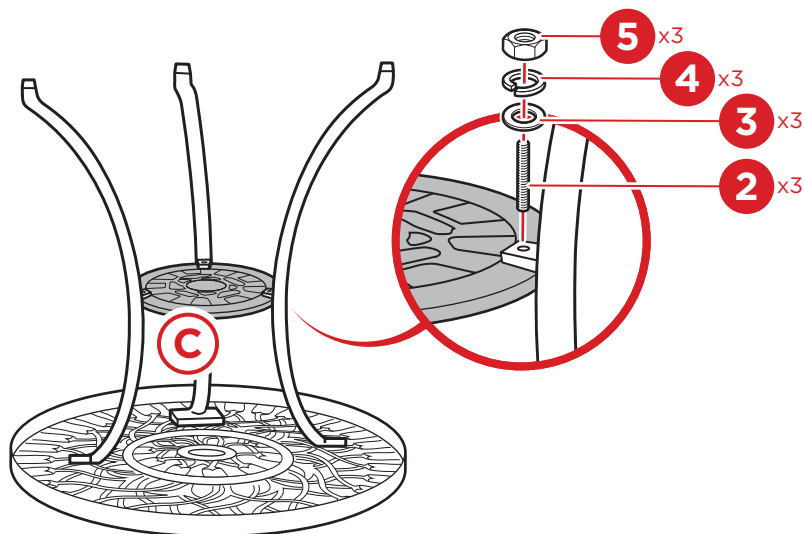
Attach three part B table legs to part A tabletop with six part 1 studs, six part 3 washers, six part 4 spring washers, and six part 5 nuts.

NOTE: Fasten hardware loosely during initial assembly. Do not firmly tighten hardware until item is completely assembled.

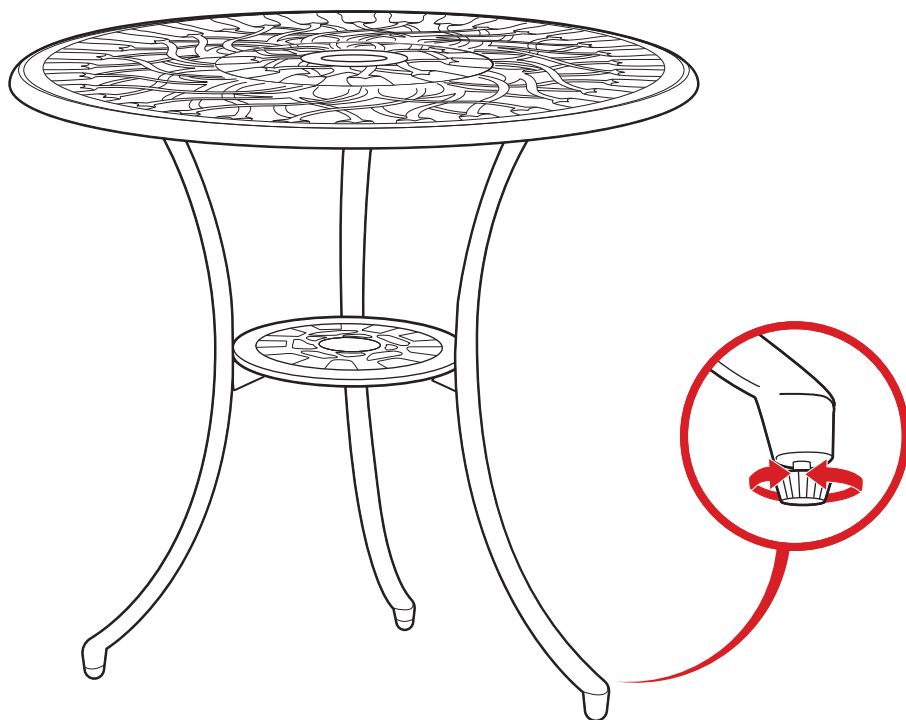
Attach part C leg support to the table legs with three part 2 studs, three part 3 washers, three part 4 spring washers, and three part 5 nuts.

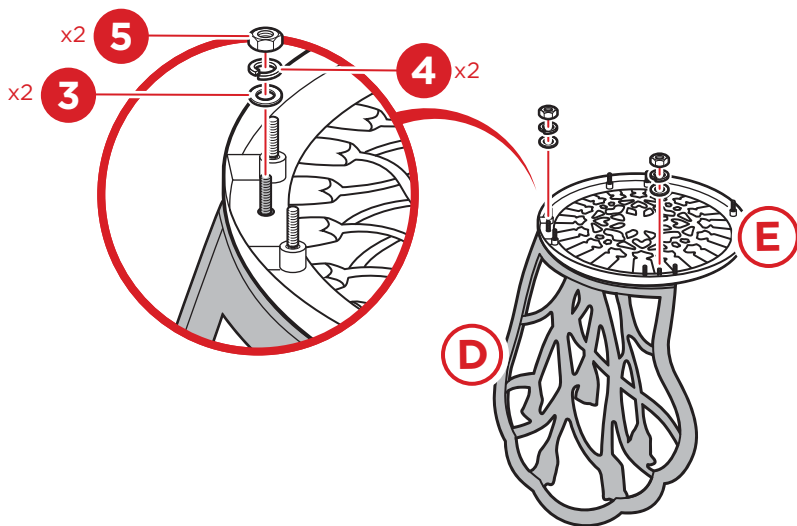
Flip the table upright. Adjust the screw-on feet until the table is level with the ground.



PRODUCT ASSEMBLY - CHAIR

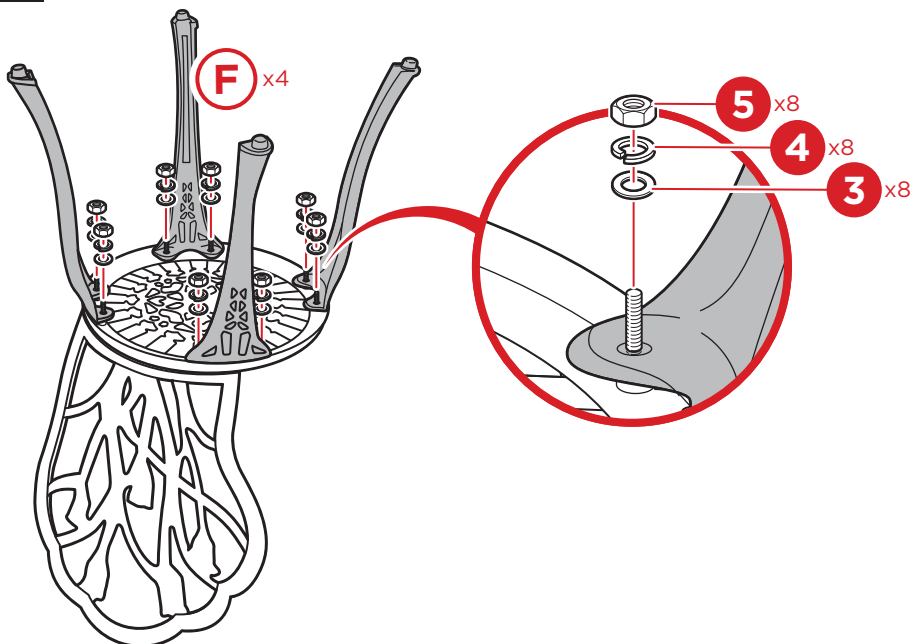

Insert the two studs on the part D backrest into the holes in the part E seat. Secure the backrest with two part 3 washers, two part 4 spring washers, and two part 5 nuts.

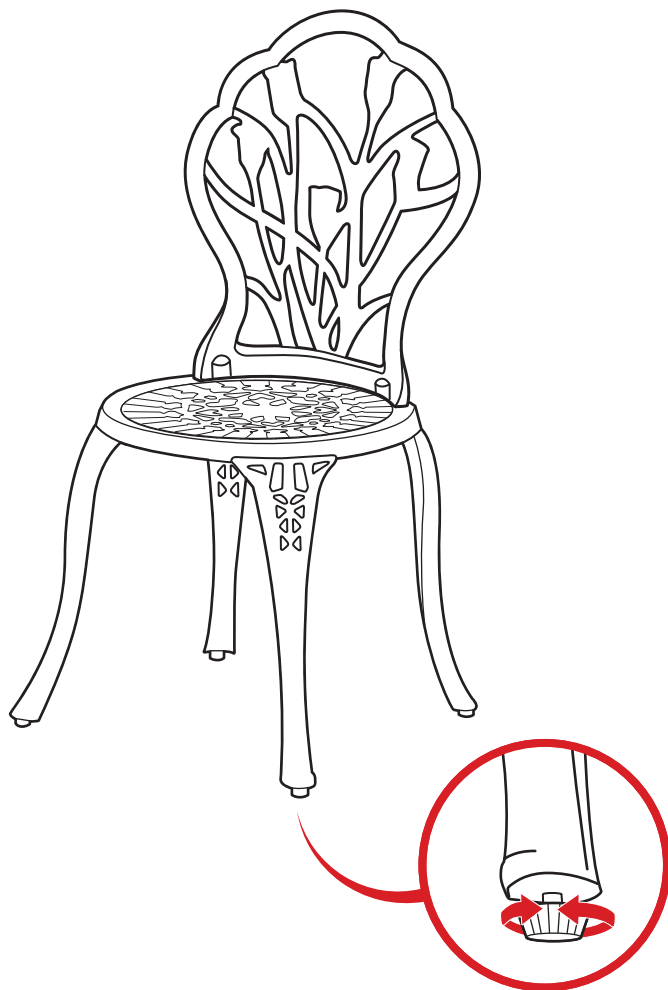
Attach four part F chair legs to the seat with eight part 3 washers, eight part 4 spring washers, and eight part 5 nuts.

Adjust the screw-on feet until the chair is level with the ground.
Repeat steps to build a second chair.

PRODUCT WARRANTY INFORMATION

All items can be returned for any reason within 60 days of the receipt and will receive a full refund as long as the item is returned in its original product packaging and all accessories from its original shipment are included.
