
PRODUCT ASSEMBLY - TABLE

1

Attach four part B table legs to the part A table frame with eight part 3 washers and eight part 1 bolts.



Flip the table onto its legs and place the part C table top onto the part A frame.



PRODUCT ASSEMBLY - CHAIR




Attach one part E right side to one part D back rest with two part 2 bolts, four part 3 washers, and two part 4 nuts.


Then place two part 5 bolt head cover and two part 6 cap nut on the part 2 bolts.

Attach one part F left side to the part D back rest with two part 2 bolts, four part 3 washers, and two part 4 nuts.

Then place two part 5 bolt head cover and two part 6 cap nut on the part 2 bolts.




2 Flip the assembly and attach the part G seat frame to back and side assembly with five part 2 bolts and five part 3 washers.



PRODUCT ASSEMBLY - CHAIR




Attach two part H chair front legs with six part 1 bolts and six part 3 washers. Attach two part I chair back legs with six part 1 bolts and six part 3 washers.

Flip the chair upright then place the part ${\sf J}$ seat cushion and part ${\sf K}$ back pillow to complete the chair assembly.

Repeat steps 1-4 to assemble a second chair.
