High Chair Mode:

Suitable for children up to 3 years old. Maximum weight 40 lb (18.1 kg). Stop using recline positions when child can sit up unassisted or is 20 lb (9.1 kg).

Booster Seat Mode: Suitable for children who can sit up unassisted (approximately 6 months) to 5 years, up to 50 lb (22.7 kg). Always use booster seat mode in the upright position.

Child Chair Mode: 3 years to 50 lb (22.7 kg) max weight.

Note: Actual fit may vary. Not all children will comfortably fit in the seat for the full weight and height ranges listed.



- **READ** all instructions before assembly and use of product.
- **KEEP** instructions for future use.
- Discontinue use if damaged, broken or if parts are missing.
- Adult assembly required.

Using the High Chair

**WARNING**

FALL HAZARD: Children have suffered **severe** head injuries including skull fractures when falling from high chairs. Falls can happen suddenly if child is not restrained properly.

- **ALWAYS** use restraints, and adjust to fit snugly.
- Tray is not designed to hold the child in the chair.
- Stay near and watch child during use.
- Stay near and watch baby during use. This product is not safe for sleep or unsupervised use. If baby falls asleep, remove baby as soon as possible and place baby on a firm, flat sleep surface such as a crib or bassinet.
- The child should be secured in the high chair at all times by the restraint system, both in the reclined and upright positions.
- It is recommended that the high chair be used in the upright position only by children capable of sitting upright unassisted.
- **DO NOT** lift or move high chair with child in it.
- **NEVER** use near stairs.
- **ALWAYS** lock wheels while child is in high chair.
- **DO NOT** adjust seat position with child in it.
- **NEVER** use high chair in reclined positions when child is able to sit upright unassisted or weighs more than 20 lb (9.1kg).

Using the Booster Seat

- **Booster Seat fits most kitchen and dining room chairs with a minimum measurement of 14.2" (36 cm) W x 16.5" (42 cm) D and backrest height of 9.8" (25 cm) H.**

**WARNING**

Children have suffered **head injuries**, including skull fractures, **after falling** with or from booster seats.

- Check that booster is **securely attached** to adult chair **before each use**.
- **ALWAYS** use restraints until child is able to get in and out of booster seat without help. Adjust to **fit snugly**.
- **NEVER** allow child to **push away from table**.
- **NEVER** **lift** and **carry** child in booster seat.
- **Stay near** and **watch** your child during use.
- **ALWAYS** fasten seat and back straps securely to adult chair.
- This booster seat is only to be used with standard kitchen or dining room chairs. **NEVER** use this product as a car seat or bath seat, on a tabletop, stool, swivel chair, or any other seating surface where the straps cannot secure it properly.
- Until child is able to get in and out of the booster seat without help (about 2 1/2 years old), the child should be secured in the booster seat at all times by the restraining system. The tray is not designed to hold the child in the chair.
- **ALWAYS** use booster seat in upright position.
- Use this product only for children capable of sitting upright unassisted.
- **ALWAYS** ensure that all protector pads are located completely on the adult chair surface.

Using the Booster Seat, Continued

- It is recommended that the booster seat be used in the upright position only by children capable of sitting upright unassisted.
- Test for proper assembly before placing child in seat.
- **ALWAYS** check that legs are fully extended and foot rest is folded inward.
- **ALWAYS** remove child before adjusting booster seat.
- **ALWAYS** ensure height adjustments are set to the same height.
- Prevent serious injury or death. Do not use in motor vehicles.

Using the Child Chair
NOT FOR ADULT USE

**WARNING**

FALL HAZARD: Children have suffered **severe** head injuries including skull fractures when falling from Child Chair.

- This product is **ONLY** for children who are 3 years or older, up to 50 lbs (22.7kg).
- **ALWAYS** lock wheels to prevent movement when child is on seat.
- This stool is only to be used on the floor.
- This toddler seat is only for use with the high chair base.
- Stay near and watch child during use.
- **NEVER** use Child Chair without toddler seat in place and locked in position.
- **NEVER** allow a child to push away from the table/ furniture.
- Recommended for indoor use only.
- **NEVER** lift or move Child Chair with child on it.
- **NEVER** use near stairs.
- **NEVER** allow child to stand on Child Chair.
- Only use for a child that is able to get in and out of the chair unassisted.
- Make sure Toddler Seat is assembled correctly and securely. Test for proper assembly before placing child in Child Chair.
