**For Control of Spotted Lanternfly on Fruit Trees, Nut Trees, Vegetable Plants, Vine Plants, Ornamentals, Almond Trees, Apple Trees, Avocado Trees, Cherry Trees, Citrus Trees, Filbert Trees, Nectarine Trees, Peach Trees, Pear Trees, Plum Trees, Prune Trees, Walnut Trees, Beans, Beets, Blackberries, Blueberries, Broccoli, Brussel's Sprouts, Cabbage, Carrots, Cauliflower, Corn, Cucurbits, Cucumber, Melons, Pumpkins, Squash, Currant, Gooseberries, Grapes, Kale, Onions, Peas, Peppers, Potatoes, Raspberries, Strawberries, Tomatoes, Flowering Plants, Flowering Shrubs, Woody Ornamentals, Roses, Trees, Houseplants, Orange Trees, Grapefruit Trees, Lemon Trees, Lime Trees, Kumquat Trees, Pecan Trees, Pistachio Trees, and Radishes in all states except TX.**

**For control of Spotted Lanternfly on vegetables, strawberry, bushberry, caneberry and grapes: measure the area to be treated. Determine how much spray solution to make up. Evenly apply the prepared mixture to the base of all plants within the 10 sq ft. of area and not just to the base of one plant in the treatment area. For fruit and nut trees: measure the distance from the tree trunk to the drip line, and round down to the nearest foot. Consult the tree rate chart to determine the number of ounces of product to use. Add specified amount of product to 1 gallon of water. Pour the mixture at the base of the tree. Fill the bucket with an additional gallon of water and pour at the base of the tree.**

Follow all other label directions, restrictions and precautions on the product label.
