LIMITED WARRANTY

Sonance warrants to the first end-user purchaser that this TRUFIG by Sonance (“TRUFIG”) brand Mounting Platform (“Product”), when purchased from an authorized TRUFIG Dealer/Distributor, will be free from defective workmanship and materials for fifteen (15) years from the date of original purchase (“Warranty Period”). TRUFIG will at its option and expense either repair the defect or replace the Product with a new or remanufactured Product or a reasonable equivalent. If a defect arises and a valid claim is received by TRUFIG within the Warranty Period, at its option, TRUFIG will repair the Product or exchange the Product with a functionally equivalent product. TRUFIG warrants repaired Products and replacement products provided hereunder against defects in materials and workmanship from the date of the repair or replacement for ninety (90) days or, if longer, for the remainder of the Warranty Period. If the Product is exchanged, the replacement product becomes your property and the Product becomes TRUFIG’s property. When a refund is given, the Product becomes TRUFIG’s property.

TRUFIG’s limited warranty applies only to the Product. The warranty does not apply to any non-TRUFIG product, even if packaged with, sold with, or used with the Product. The warranty excludes, without limitation, any theft of the non-TRUFIG product while used with the TRUFIG product. The warranty excludes scratching or surface damage to any non-TRUFIG product, even if packaged with, sold with or used with the Product. This warranty applies only to the normal use of the Product, normal wear and tear excepted, in accordance with use instructions, if any, provided with the Product (either in writing or through a hyperlink to such instructional materials). This warranty does not apply to damage caused by accident, abuse, misuse, or modification of the Product.

To the maximum extent permitted by law, this warranty and the remedies set forth therein are exclusive and in lieu of all other warranties, remedies and conditions, whether oral or written, express or implied. TRUFIG specifically disclaims any and all implied warranties, including, without limitation, warranties of merchantability and fitness for a particular purpose. If TRUFIG cannot lawfully disclaim or exclude implied warranties under applicable law, then to the extent possible any claims under such implied warranties shall expire on expiration of the warranty period. No TRUFIG reseller, agent, or employee is authorized to make any modification, extension, or addition to this warranty.

To the maximum extent permitted by law, TRUFIG is not responsible for direct, or for special, incidental or consequential damages resulting from any breach of warranty or condition, or under any other legal theory, including without limitation any costs of replacing personal property.

For consumers who have the benefit of consumer protection laws or regulations in their country of purchase or, if different, their country of residence, that cannot be disclaimed as set forth above (“consumer laws”), the benefits conferred by this warranty are in addition to all rights and remedies conveyed by such consumer laws. To the extent that liability under such consumer laws may be limited, TRUFIG’s liability is limited, at its sole option, to replacement or repair of the products.
