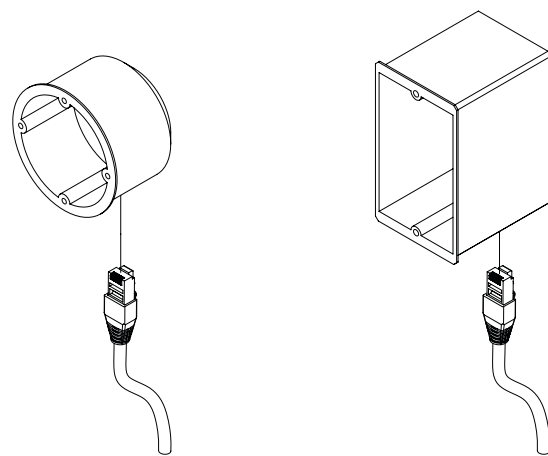

Mounting Wall-S1

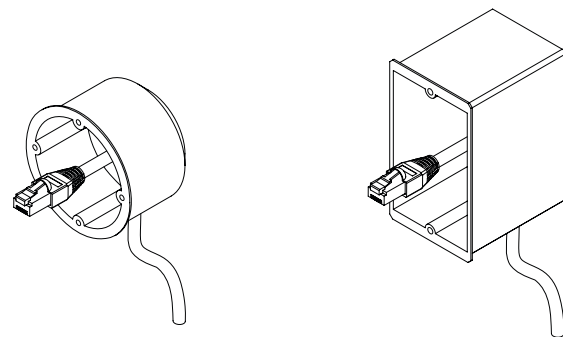
1. Feed the ethernet cable through the electrical box.

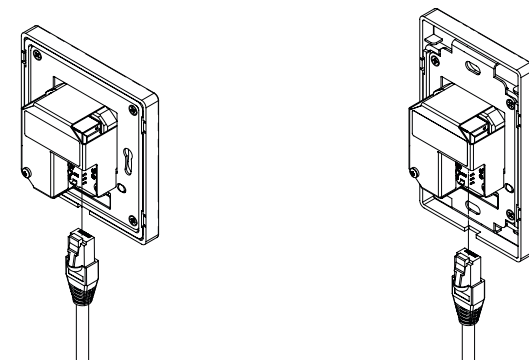

3. Connect the ethernet cable to the Wall-S1 unit.



4. Click off the front panel. Screw the Wall-S1 unit into the electrical box.
