
- Do not stand on or use any part of this set as a step ladder.


ACCESSORIES



Attach a part B side panel to two part A end panels with four part 1 screw sets.




NOTE: Do not fully tighten screws in this step.




Slide the part C foosball playfield into the designated slots on the end panels.

NOTE: If necessary, adjust the spacing of the end panels so the playfield properly slides in.






Attach the other part B side panel with four part 1 screw sets.






Insert a part D player rod into a goalie slot, then slide a part 5 bumper, part 4 stop ring, part E red player, another stop ring, and bumper onto the rod. Attach the parts to the rod with three part 2 screws.

Repeat to assemble the other goalie player rod.





Insert a part D player rod into a slot, then slide a part 5 bumper, three part E or part F red/blue players, and another bumper onto the rod. Attach the players to the rod with three part 2 screws. Repeat to assemble three additional player rods.




Ensure that rods are arranged according to the diagram and players on the same team face the same direction.





Attach two part G scorers with four part 3 screws.

Slide six part 7 handles onto the ends of rods with a hole. Slide six part 6 end caps onto the ends of rods without a hole.






If necessary, use a drop of liquid soap to help handles slide onto the rods.

Flip the part H billiards playfield over. Attach two part I left legs and two part J right legs with eight part 1 screw sets.

Billiards:

• Remove all playfields to play billiards.





Table Hockey:


- Place the part K hockey playfield on the billiards table. Use four part 8 dowels to secure the playfield.
- Adhere the felt pads to the hockey pushers.



PLAYING GAMES


Table Tennis:

- Flip part K to the table tennis playfield and place it on the billiards table. Use four part 8 dowels to secure the playfield.
- Install the table tennis net in the designated holes.



Foosball:

• Place the foosball assembly on the billiards table or hockey/table tennis playfield. Use four part 8 dowels to secure the foosball assembly.
