PROBLEM

Patterson-UTI has extensive oil and gas drilling operations, with a footprint in 6 different states for fracturing, and 132 active land-based rig fleet operations. Some drilling crews were using non-compliant or non cutresistant gloves that were leading to cuts and lacerations. With employee safety as a core principle, the safety leadership at Patterson-UTI recognized the need for conformity and consistency when it came to providing (and ensuring) appropriate hand protection for use on and around the oil rigs. It would be more expensive upfront, but save money (and even generate additional revenue) in the long term.

The increase in hand injuries dealt a one-two punch to the company. Patterson-UTI's safety track record and TRIR rating (Total Recordable Incident Rate) began to suffer. This caused both an increase in their insurance rates, and a loss of bids for new business.

SOLUTION

Patterson-UTI needed to find new hand protection that kept their workers safe, was compliant, and helped reverse the trend of rising worker injury rates and insurance costs. The gloves also needed to be suitable for work in oil and gas; specifically, they needed to have a cotton corded palm.

On the drill floor, cotton is king. Although it is a natural fiber and not considered a particularly high-tech fabric, it is still the best for handling crude oil, diesel, and natural gases. Mechanix Wear's M-Pact Cotton Grip CR4 glove, specifically designed for oil and gas industry hazards, was proposed as a possible solution. The absorbant cotton palm with a printed silicone grip, is reinforced and protected by an internal layer of ANSI Level 4 cut-resistant fabric to prevent punctures and lacerations on the job. Besides having a suitable cut rating, these gloves are also compliant for impact protection thanks to the full-coverage anatomical TPR resistance for the back of the hand.

The M-Pact Cotton Grip CR4 glove provided a solution - not a just a replacement of one brand with another. Patterson-UTI workers went from having to wear a non-compliant glove without cut-resistance, to a compliant glove with multi-hazard protection. The cut and impact-resistance provided by the new gloves went a long way to reduce the number of cuts, lacerations, and other hand injuries among workers.
