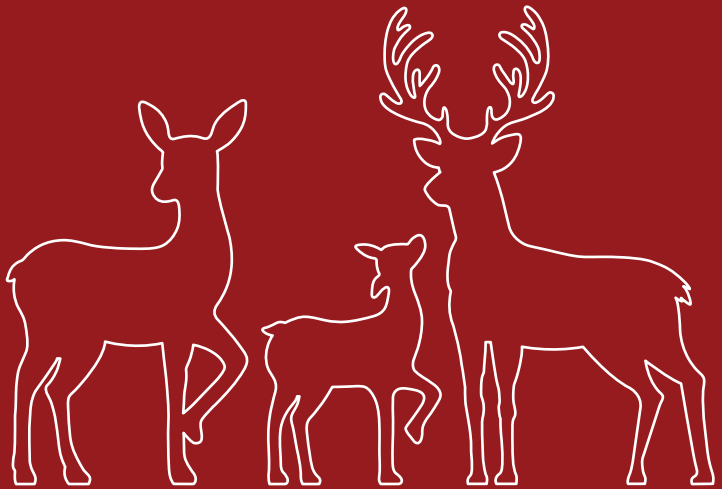

3-Piece 2D PVC Deer Family

- Assemble this product on a flat level surface near its intended display space.
- This product is not easily transported after assembly. Please avoid excessive movement and reorientation.
- If any parts are missing, broken, damaged, or worn, stop using this product until repairs are made and/or factory replacement parts are installed.
- Do not use this item in a way inconsistent with the manufacturer's instructions as this could void the product warranty.
- This set includes three figures: one buck, one doe, and one fawn. Construct the figures using the appropriately sized pieces. Do not attempt to mix the three figure assemblies.
- This product is intended for residential use only.

- Do not lean, sit, or stand on or use any part of this item as a step ladder.
- Do not lean, sit, or stand on/in the figures or support structure.
- Keep item away from all heat sources (fireplace, stove, heater, etc.).

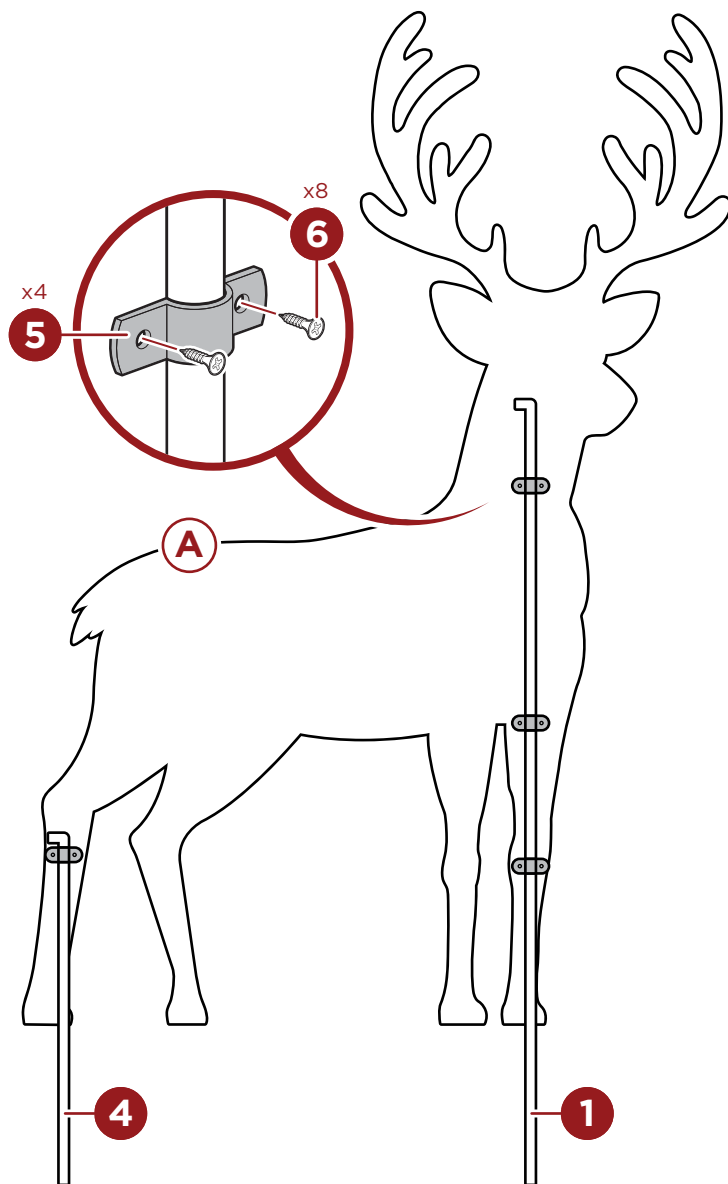

PRODUCT ASSEMBLY (BUCK)

1. Attach one **part 1 stake** to the **part A Buck figure's front leg** by placing three **part 5 stake retainers** and loosely securing with six **part 6 screws**, two screws per retainer.
2. Attach one **part 4 stake** to the **part 1 Buck figure's back leg** by placing one **part 5 stake retainers** and loosely securing them with two **part 6 screws**, two screws per retainer.

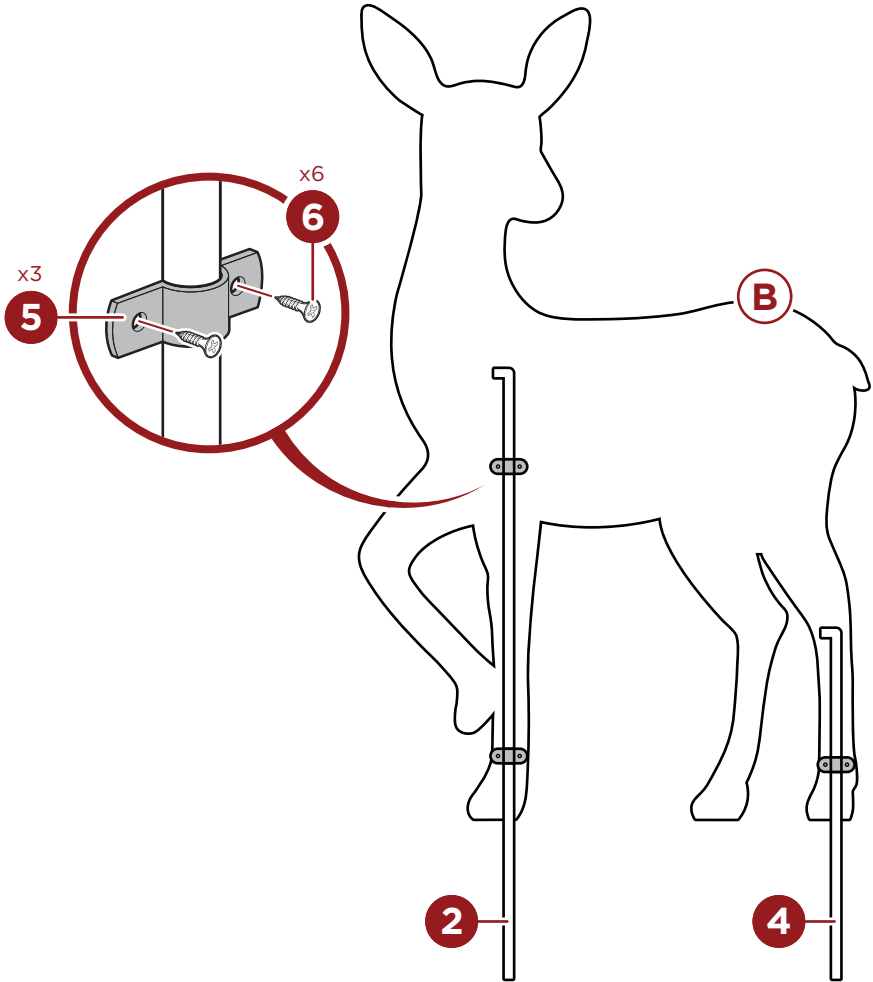
NOTE: Do not attach the retainer before inserting the stakes.



PRODUCT ASSEMBLY (DOE)

1. Attach one **part 2 stake** to the **part B Doe figure's front leg** by placing two **part 5 stake retainers** and loosely securing with four **part 6 screws**, two screws per retainer.
2. Attach one **part 4 stake** to the **part B Doe figure's back leg** by placing one **part 5 stake retainers** and loosely securing with two **part 6 screws**, two screws per retainer.

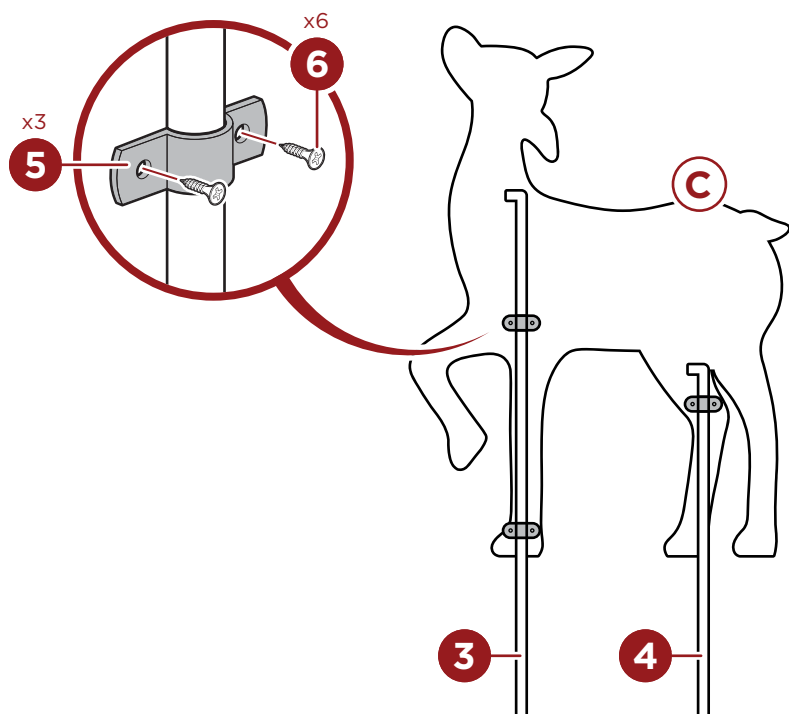
NOTE: Do not attach the retainer before inserting the stakes.



PRODUCT ASSEMBLY (FAWN)

1. Attach one **part 3 stake** to the **part C Fawn figure's front leg** by placing two **part 5 stake retainers** and loosely securing with four **part 6 screws**, two screws per retainer.
2. Attach one **part 4 stake** to the **part C Fawn figure's back leg** by placing one **part 5 stake retainers** and loosely securing with two **part 6 screws**, two screws per retainer.

NOTE: Do not attach the retainer before inserting the stakes.

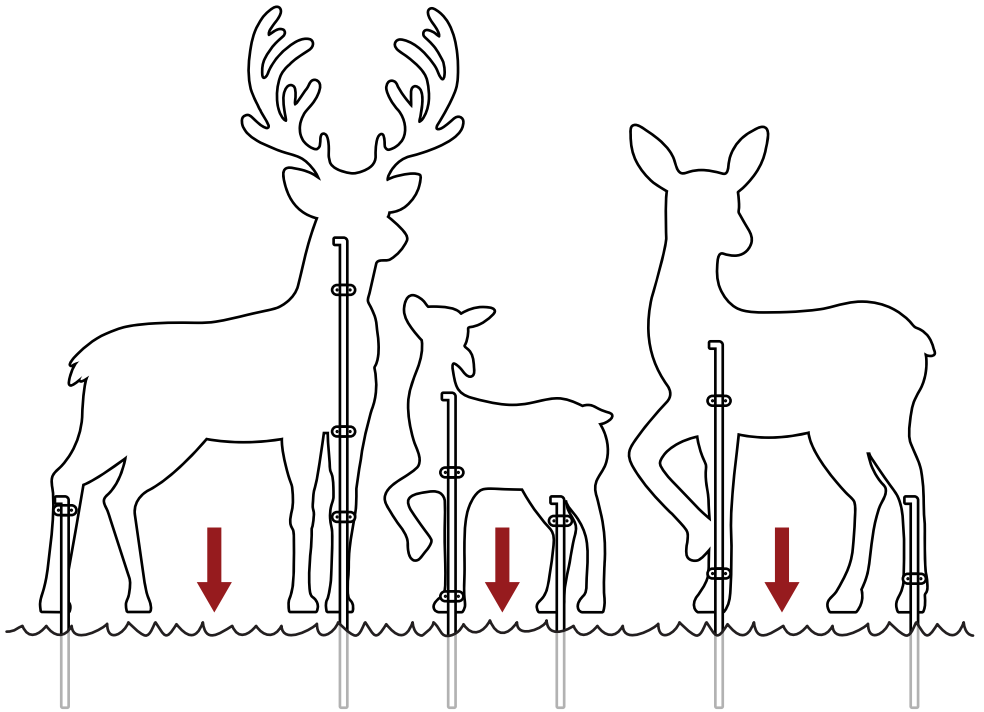


INSTALLATION

Arrange your assembled figures as desired and press down on the tops of the stakes.

If the ground is firm, use a mallet to tap the stakes into the ground.

NOTE: This product is intended for grass or dirt, do not attempt to sink the stakes into concrete.
