


Multi Diameter Frame

What's In The Box



Tools Needed

The Multi-Frame requires very few tools for installation. A drill or screwdriver and a hammer will help with installation.








Installing the Multi-Frame




Make sure all power is turned off before beginning installation

- 1 Carefully unpack the frame from its packaging. Inspect product for defects due to shipping.
- 2 If necessary, adjust hangar bar length by separating bars, snapping to length at score marks, and reassembling.
- Remove inner sections of frame to the desired size.
 All inserts: 3" fixtures
 1 insert removed: 4" fixtures
 2 inserts removed: 6" fixtures

Double sided tape included to mount remote drivers. Place tape on frame in open area, leaving protective film on top until fixture is installed.



Position frame between joists, ensuring hangar bars are in the correct position. Bottom edge of hangar bars should be level with the bottom of the joists.



GENERAL PRODUCT WARRANTY. Each NICOR product will be free from defect in materials and workmanship for a period of one (1) year from the date of delivery to the end-user. Poles must be installed by a properly insured and licensed contractor, using the supplied anchor bolts and mounting templates. Using a pole product in any manner other than as disclosed in the Application Specification automatically voids the warranty and may cause failure resulting in injury, death, or significant property damage.
