- Slim polymer body with gasketing to prevent water instrusion
- · Polycarbonate diffuser faceplate
- Powdercoated faceplates in louvered and open face designs

Optical System

- Polycarbonate diffuser creates uniform distribution
- Louvered faceplate conceals LED and provide a footpath directed distribution pattern
- Frosted open faceplate provide enhanced illumination in a wide distribution

Electrical

- Custom driver design minimizes installation depth
- 6" leads for Hot and Neutral connections. No ground required due to polymer housing.
- Input voltage of 120VAC, 60Hz
- Photocell enabled model provides dusk to dawn operation: light off at day, on at night.
- Dimmable with compatible leading edge (TRIAC) and trailing edge (ELV) dimmers
- Operating temperature rating of -4°F to 104°F (-20°C to 40°C)

- White powder coat finish standard
- Optional faceplates available in Black and Oil-Rubbed Bronze

Mounting and installation

- · Mounts directly in most metal, non-metallic and non-metallic remodel single gang junction boxes
- Faceplates allows fixture to be mounted in horizontal or vertical orientation
- Includes two wire nuts and mounting screws
- Wet location approved for indoor and outdoor use
- For installations where power surge may be possible, NICOR recommends installing additional surge protection at the electrical distribution panel


