









Tools Needed

This LED Recessed Downlight requires very few tools for installation. A screwdriver, a wrench, and a pair of wirecutters will help to install the driver and downlight. Additionally, the installer must provide one Romex connector.




Installing the RRD LED Recessed Downlight




Make sure all power is turned off before beginning installation

- 1 Identify fixture location and use the included paper template to cut the mounting hole. Hole diameter is 2.83" (72mm).


- 2 Remove the knockout on the junction box and attach Romex connector to junction box.



- 3 Open the driver door and connect supply wiring as shown below. Close cover.



- 4 Select CCT by setting switch on end of driver to the desired setting.




Installation Continued




Make sure all power is turned off before beginning installation


- 5 Insert driver into mounting hole, leaving fixture cable exposed.




- 6 Twist lock the desired trim onto the light engine.



- 7 Connect light engine to driver by inserting and twisting the connectors.



- 8 Insert the light engine into the ceiling by pressing the clips upwards. Insert the light engine into the mounting hold and release the clips.




- 9 Turn power on and confirm fixture is working properly.


Installation with Mud Ring Trim

- 1 Identify fixture location and use the referenced dimensions to cut the mounting hole. Hole diameter is 2.64" (67mm) for round trim, 2.83" x 2.83" (72mm x 72mm) for square trim.


- 2 Align the edge of the mud ring trim to the drywall hole and screw into place. Note: Install with arrow up.




- 3 Plaster over mud ring trim, being careful not to fill past raised rim.




- 4 Remove the knockout on the junction box and attach Romex connector to junction box.



- 5 Open the driver door and connect supply wiring as shown below. Close cover.



- 6 Select CCT by setting switch on end of driver to the desired setting.




Installation with Mud Ring Trim Continued


- 7 Attach the reflector to the light engine by aligning and twist to lock into place.



- 8 Connect light engine to driver by inserting and twisting the connectors




- 9 Insert the driver through the mud ring trim. Insert the fixture into the mud ring trim and twist to lock into place.




- 10 Turn on power and confirm the fixture is working properly.

Field swapping fixture optic


- 1 Remove the lens holder from the light engine by remove the four (4) phillips head screws.




- 2 Remove the existing lens and reflective cone from the light engine.



- 3 Insert the reflective cone and new optic into the light engine.



- 4 Reinstall the lens holder using the four (4) phillips head screws. Be careful not to over-tighten.

This warranty extends only to the first consumer purchaser and is not transferable. A consumer wishing to invoke the terms of this limited warranty must first obtain a RGA number within 30 days of discovery of the defect, and return the product to NICOR for inspection. Once verified to be covered by this limited warranty, NICOR will, at its sole discretion, repair, replace, or refund the purchase price of any product that does not conform to this limited warranty. If NICOR, at its sole discretion, determines that the product should be repaired or replaced, this warranty is limited to the reasonable, customary, and necessary costs and expenses associated with the repair/replacement.
